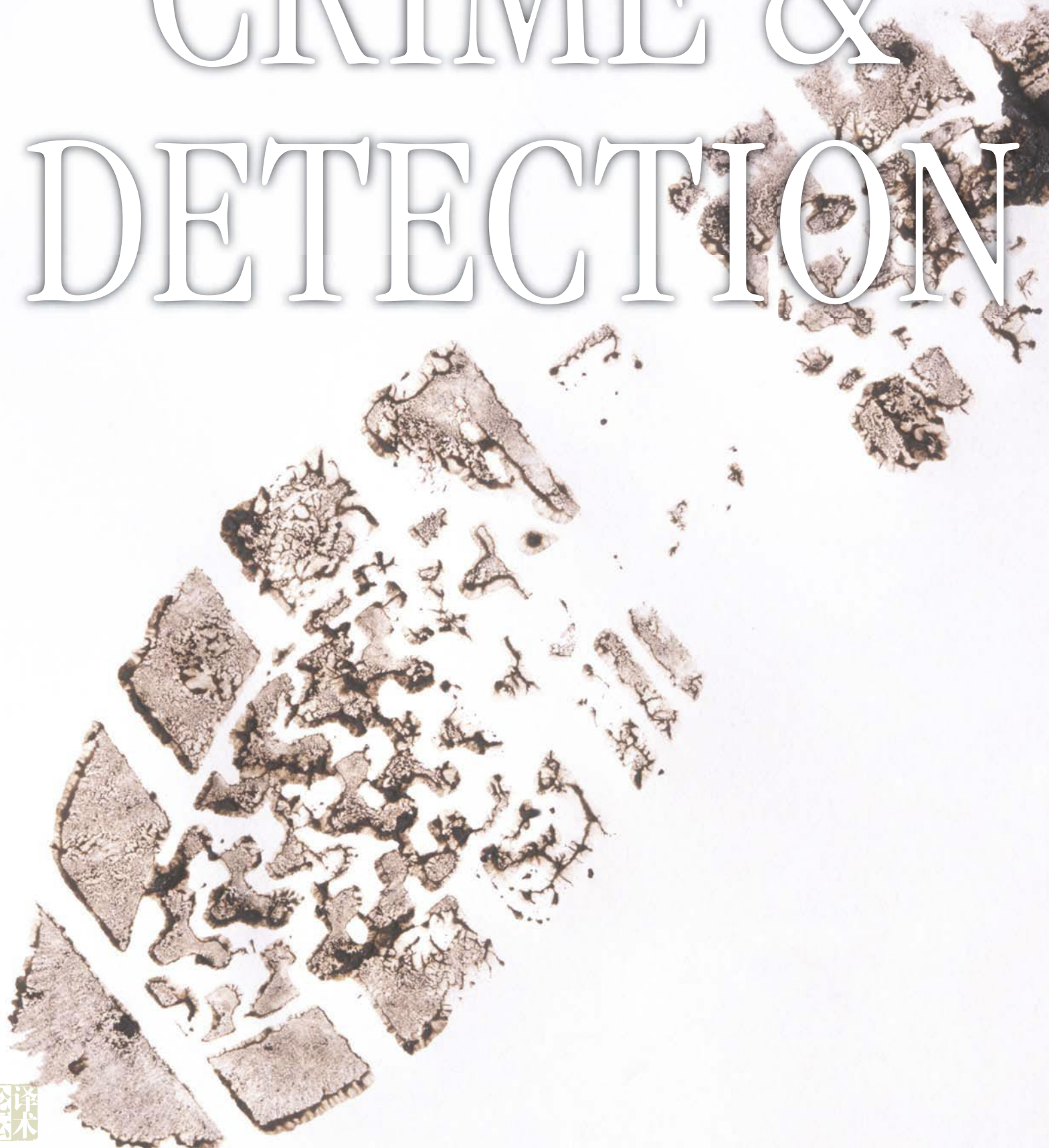

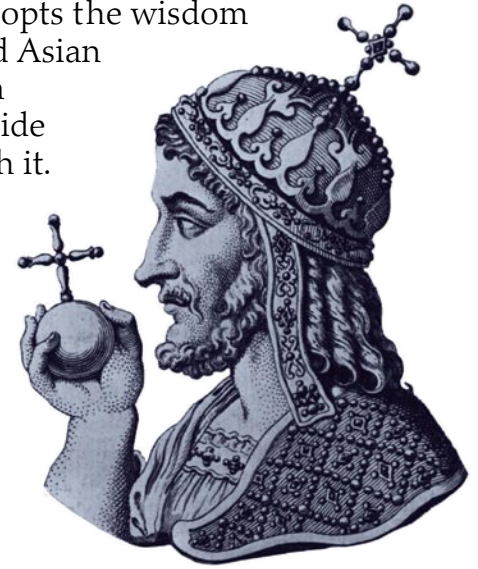


CAIN AND ABEL

According to the biblical book of Genesis, Cain, the elder son of Adam and Eve, was a farmer. He made a sacrifice of corn to God. His younger brother, Abel, a shepherd, offered his best sheep. God accepted the sheep, but rejected the corn. Moved by jealousy and anger, Cain killed his brother. This, says the Bible, was the first murder.

Crime and society

THERE ARE FEW CORNERS of the world that are free from crime. Crime is defined in the dictionary as “an act punishable by law,” so its nature depends on the laws of each society. The laws of a Judeo-Christian society follow the teachings of the Bible; many of the moral values of these societies are derived from the Ten Commandments. An Islamic society adopts the wisdom of the Koran. Among many African and Asian groups, tribal rules of conduct are often decided by a council of elders, who decide both what is a crime and how to punish it. Whatever the basis of their legal system, all societies must deal with people who defy the law.



EMPEROR JUSTINIAN

Flavius Anicius Sabbaticus Justinianus, called Justinian the Great (483–565), was a Byzantine emperor who laid the foundations of Roman law. Many of the modern world’s legal systems are based on this body of law, called the Justinian Code.



LOOTING AND BLACK MARKET SALES

Sometimes the results of war are destruction and lawlessness. In this confusion, some people steal goods from damaged houses and shops. This practice is called looting. The term comes from the Hindi word *lut*, which means “booty.” Looting also occurs during peacetime – when there are inner-city riots, for example. Closely associated with looting is the secret selling of food and other items that are either scarce or heavily rationed. This is known as selling on the “black market.”

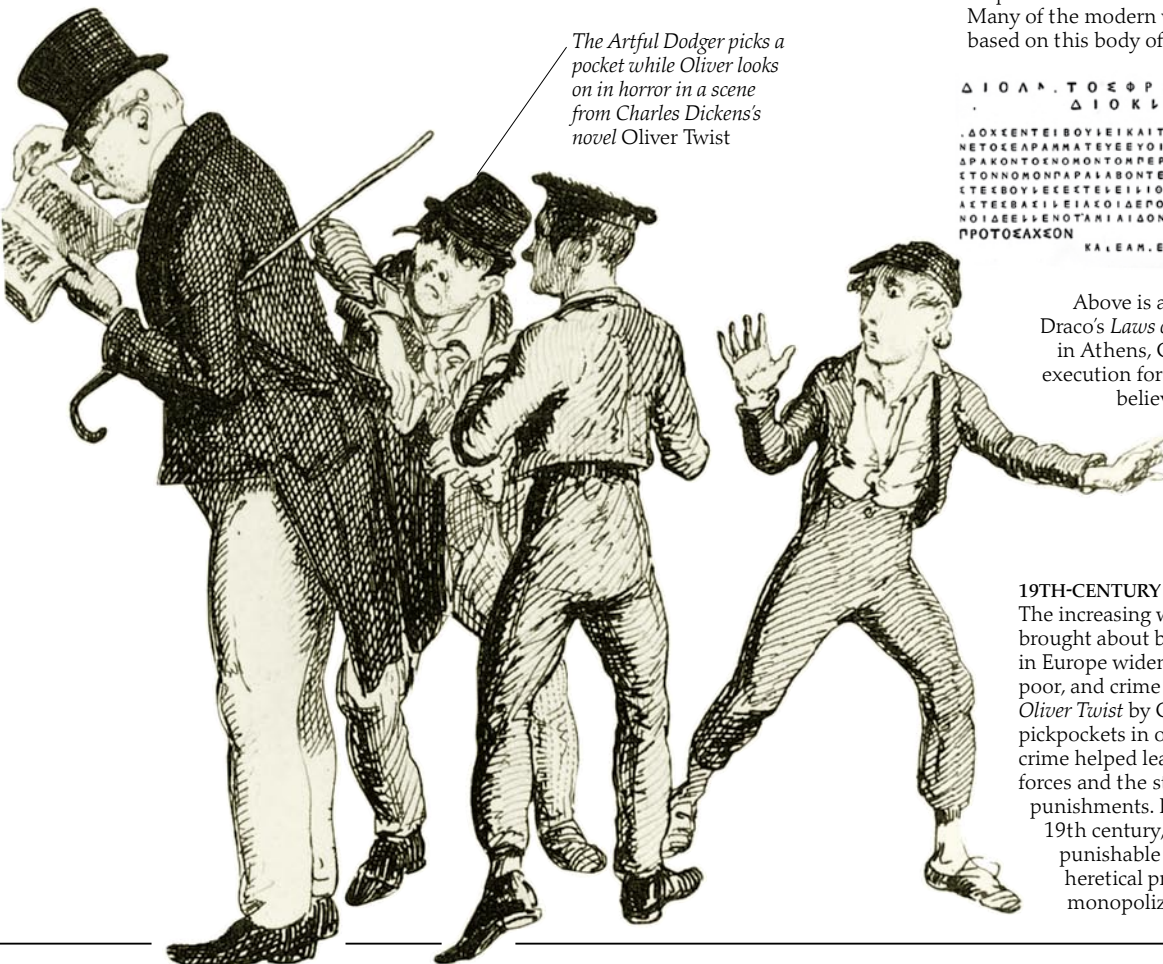

DRACONIAN LAWS

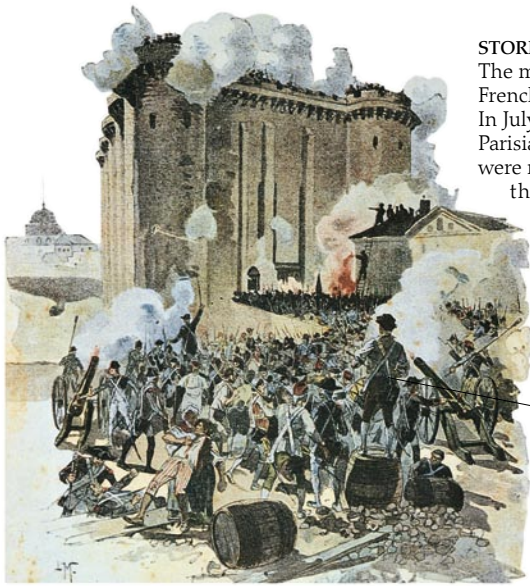
Above is an extract in the original Greek of Draco’s *Laws on Murder*. Draco was a lawmaker in Athens, Greece (624–621B.C). He ordered execution for all crimes, including laziness. He believed even minor crimes warranted death, and therefore could not find a greater punishment for more serious crimes. The term “Draconian laws” evolved from Draco’s harshness.

19TH-CENTURY CRIME WAVE

The increasing wealth of factory owners brought about by the Industrial Revolution in Europe widened the gap between rich and poor, and crime grew. This illustration from *Oliver Twist* by Charles Dickens shows some pickpockets in operation. This increase in crime helped lead to the founding of police forces and the strengthening of laws and punishments. In the first quarter of the 19th century, there were 156 crimes punishable by death, including heretical preaching and monopolizing corn.



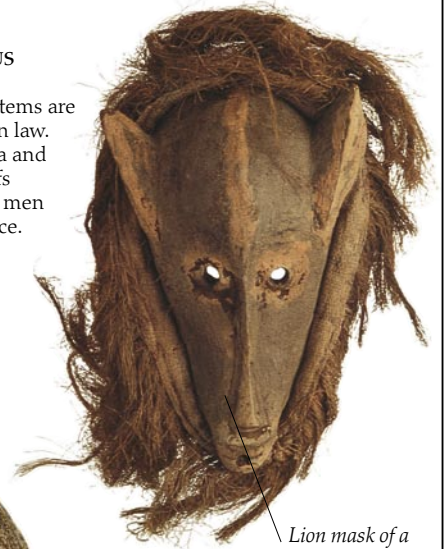

STORMING THE BASTILLE
 The main prison in Paris during the French Revolution was the Bastille. In July 1789, it was stormed by a Parisian crowd and the prisoners were released. The most unusual of these liberated "prisoners" were several hundred books that had been imprisoned for the crime of being critical of the monarchy.

LAW IN VARIOUS CULTURES
 Not all legal systems are based on Roman law. In parts of Africa and Asia, tribal chiefs advised by holy men administer justice. In North Africa, shamans and witch doctors dictate the law.

THE CASE OF PETE MARSH
 In 1984, a prehistoric corpse was unearthed from a peat bog on Lindow Moss, Cheshire, England. A medical examination revealed that the "bog man," who became known as Pete Marsh after the place he was found, had suffered many deliberate injuries – a stab wound to the chest, bludgeoning of the head, strangulation, and a cut throat – any of which could have caused his death. There can be no doubt that he was killed; the question is, was it murder, or ritual sacrifice?



Law and order

SINCE ALL SOCIETIES SUFFER CRIMES, they have all developed systems of law by which to judge wrongdoers and assist the law enforcement officers in bringing criminals to justice (pp. 12–13). Officers try to keep order by preventing people from committing crimes and thereby breaking the law. In many countries, laws fall into two categories: “common” and statutory. “Common” law is based on previous legal judgments and is often unwritten law. Statutory law is a collection of written laws, or statutes, enacted by parliaments, congresses, and legislatures.

BOBBY'S UNIFORM
Sir Robert Peel was the British home secretary from 1822 to 1830. He founded the Metropolitan Police at Scotland Yard. These officers became known as “peelers” or “bobbies,” shortenings of Sir Robert’s name. The force was known for its distinguished uniform.

WOODEN RATTLE

A wooden rattle was used to signal an alarm or call for help. Rattles were carried in a pocket of one of the tails of the jacket. Rattles, rather than whistles, were used initially because hotel doormen used whistles to call cabs. By 1880, however, increasing traffic noise made whistles essential.

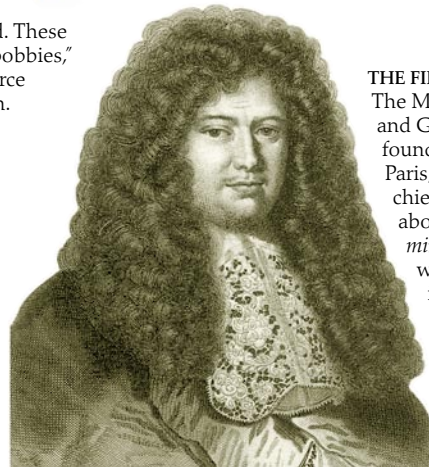


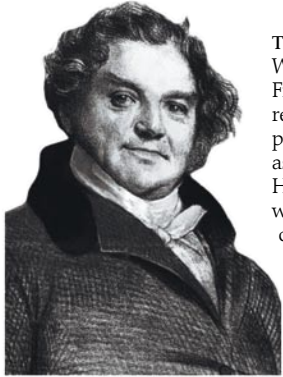
BOW STREET RUNNERS

In 1750, crime had become such a problem in London that Sir Henry Fielding, the magistrate at Bow Street Court, assembled a force of six men to patrol the streets in and around the city. They were called Bow Street Runners because night and day they were available, within 15 minutes, to “run” after a criminal. Despite growing in numbers and effectiveness, the Runners were disbanded in 1829.

THE FIRST FRENCH POLICE

The Marquis de Louvois (left) and Gabriel La Reynie founded the police force in Paris, France, in 1667. As chief of police, La Reynie abolished the *cour des miracles*. A *cour des miracles* was an area of sanctuary in the center of each French city in which beggars and bandits hid from the law. He also introduced a mounted and a pedestrian police force in Paris.





THIEF AND DETECTIVE
When the infamous French thief François-Eugène Vidocq was released from his last term in prison in 1809, he offered to act as a spy for the French police. He recruited other ex-convicts, who used their knowledge of criminal activity to make a very effective detective force.

THE STRONG ARM OF THE LAW
Tom Smith was a familiar figure in London's West End in the 1850s. He was 6 feet 5 in (1 m 96 cm) tall and weighed over 287 lbs (130 kg). It was said he could stop a fight merely by appearing at the scene.

SIGN OF OFFICE

Tipstuffs were used for identification. They were carried by English sheriffs' officers or bailiffs when delivering legal warrants. The officers themselves also became known as "tipstuffs."

BADGES OF OFFICE

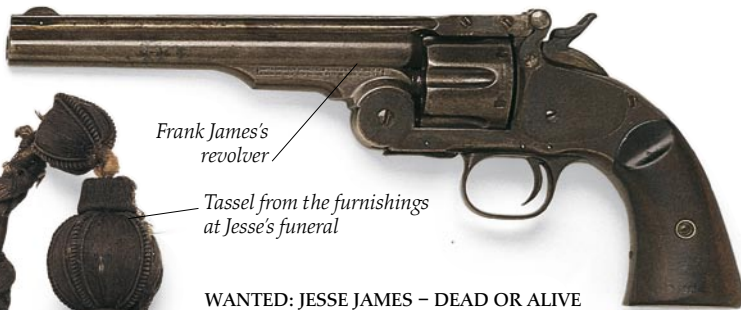
Public officials have always needed identification to prove their authority. It is especially important for a law enforcement officer – whether a sheriff in the Wild West or a detective constable in London – to show that he or she has the power to search and arrest.

ALLAN PINKERTON

Born in Scotland in 1819, Allan Pinkerton arrived in the United States in the early 1840s. In 1850, he founded Pinkerton's National Detective Agency in Chicago. The agency still exists today. Among other feats, Pinkerton foiled an assassination attempt on Abraham Lincoln.

WANTED: JESSE JAMES – DEAD OR ALIVE

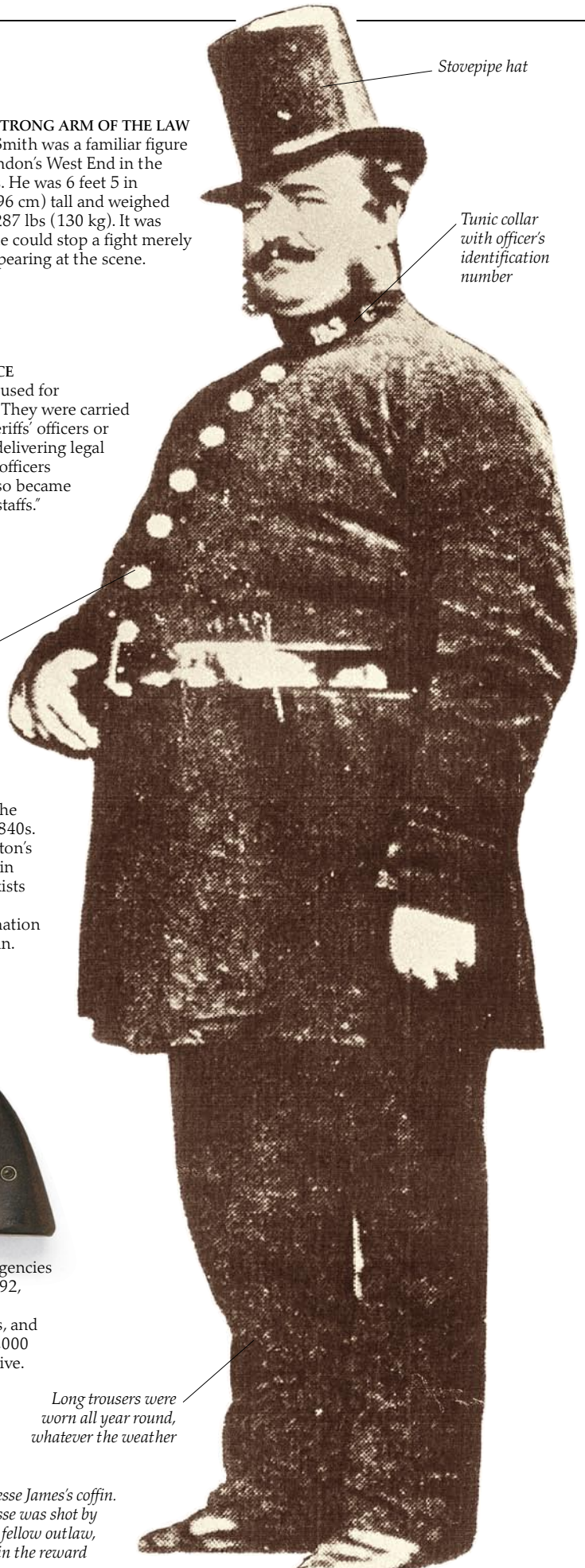
Offer of a money reward for the capture of criminals is one method used by law enforcement agencies in an effort to maintain order. Between 1866 and 1892, Jesse James and his brother Frank headed a band of outlaws in the Wild West who robbed banks, trains, and stagecoaches, and killed at least 10 people. A \$10,000 reward was offered for Jesse's capture, dead or alive.

Justice and sentencing



PILLORY

Putting minor criminals on display for the scorn and amusement of the public was first done by the ancient Greeks and Romans. In medieval times, a pillory was used. It trapped the neck and wrists of the felon. He or she was then displayed in the village square or carried through the town. The public threw rotten vegetables at the criminal; an especially disliked criminal would be pelted with stones.

IN MOST PARTS of the modern world the ideas of *justice* and *sentencing* go hand in hand. *Justice* is simply a means by which punishment can be given fairly according to the crime and the circumstances of the convicted criminal. The *sentence* is the punishment imposed. Most national laws consider crimes of violence against people very serious, and the punishments for these offenses are most severe. In a criminal action, a governmental unit asks the court to try an alleged offender. In the United States, that unit may be the local, state, or federal jurisdiction. For example, murder and robbery are generally state crimes.

CHINESE COURT

A prisoner is being brought before a magistrate in a 16th-century Chinese court. By then, China already had a very efficient legal system based on the laws of Confucius, a famous Chinese philosopher of the first century B.C.

PASSING THE TIME

During his 54-year stay in prison for murder, Robert Stroud studied the diseases of canaries. He became a leading authority and wrote several books on the subject, including this one. He came to be known as "the Birdman of Alcatraz."



LYNCHING

Lynching is the illegal killing (usually by hanging) of an accused prisoner by a mob. The lynchers usually think that the suspected offender will escape just punishment. Lynching can include beating, burning, stoning, or hanging.

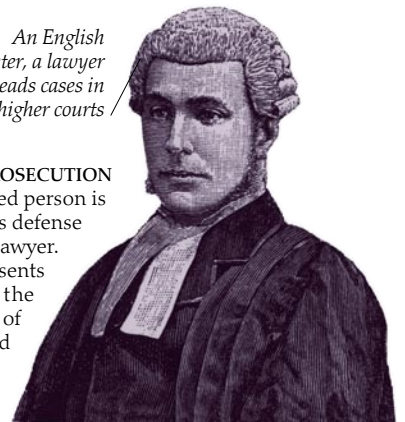
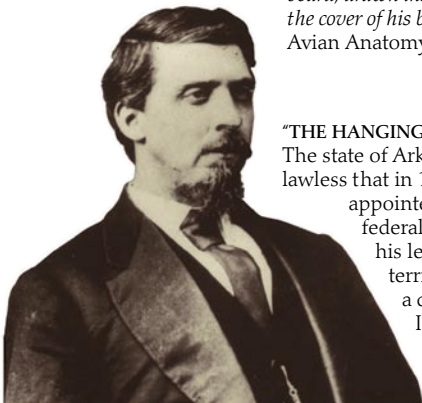

"THE HANGING JUDGE"

The state of Arkansas had become so lawless that in 1875 President Ulysses Grant appointed Isaac Charles Parker as a federal judge in Fort Smith. During his legal career in Jesse James territory, Parker had developed a deep hatred for lawbreakers. In 21 years on the bench, Parker issued more than 160 death sentences, earning him the name "The Hanging Judge."

DEFENSE AND PROSECUTION

In many countries, an accused person is given the chance to have his defense presented to the court by a lawyer. A prosecuting counsel presents the opposite case, maintaining the accused's guilt. A jury, a group of independent, randomly selected people, decides whether or not the prosecution has proven the accused's guilt.





COURTROOM CAPERS
 This scene depicts an English police court in the early 19th century. It is possible that the violent young men facing the magistrate were arrested for being drunk and disorderly. Such scenes are extremely rare in today's courts, partly because of the fear of harsher sentences, and partly because of the presence of trained security staff.

"BLACK JACK" KETCHUM

Ketchum was born in New Mexico in 1866. He formed a gang that specialized in train robberies, but they had little success. "Black Jack" was a heavy drinker, not afraid to use his gun. He was finally arrested after being injured in a shoot-out. He was convicted of the murder of Sheriff Edward Farr and hanged.



GUARD DUTY

Either because of the fierce guards or the ferocious currents surrounding the island, only three inmates ever managed to escape the federal prison at Alcatraz, and they have never been seen or heard of since.

"THE ROCK"

Alcatraz, the world's most notorious prison, was built on a rocky island in San Francisco Bay. Originally a military prison, "The Rock" served as a federal penitentiary from 1934 to 1963. Dangerous currents around the island made escape impossible. Famous inmates included Al Capone, "Machine Gun" Kelly, and Robert Stroud, "the Birdman of Alcatraz."

Bounty hunters and thief takers

WHETHER BOUNTY HUNTERS in the American Wild West or thief takers in 18th-century Britain, some people have always been ready to catch criminals for a rich reward. There were few sheriffs in the new, 19th-century towns of the United States, so bounty hunters flourished as rough-and-ready peacekeepers. Thief taking became popular in England after the passage of the Highwayman Act in 1692. This act offered large rewards for the capture of highwaymen and other criminals. If the thief takers were criminals themselves, they would be granted a pardon for bringing in the accused. This meant that it was easy for a guilty person to send an innocent one to the gallows.

THE PAYOFF
Bounty hunters and thief takers were paid well. In Britain, a thief taker earned 40 pounds, and the highwayman's horse and goods, for each convicted thief. In the United States, the bounty hunter's reward depended on the notoriety of the criminal. The first reward offered for the outlaw Jesse James was \$500; the last was \$25,000.



BOTH SIDES OF THE LAW
Jonathan Wild was one of London's most ruthless and powerful criminals. He also brought criminals to justice. Calling himself the "Thief Taker General of Great Britain and Ireland," he used a vast network of criminal informers to become the most famous thief taker London had ever known. He even sent some of his fellow criminals to the gallows. Wild was hanged in 1725, at the age of 43.

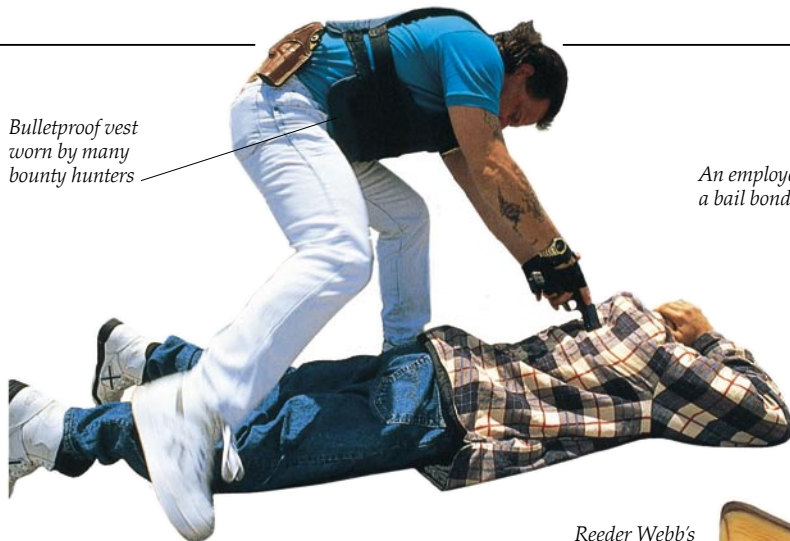
TRACKER
In 1880, Patrick Floyd Garrett, the sheriff of Lincoln County, New Mexico, captured the notorious outlaw Billy the Kid. The Kid escaped from jail but not from Garrett, who tracked him for three months and finally shot him dead at Fort Sumner, New Mexico, in July 1881.

BILLY THE KID
Billy the Kid never went to school. Born in New York City in 1859, he was brought up on the legend of Jesse James (p. 11). He became a gambler, a rustler (a cattle and horse thief), and a killer. Billy's real name is believed to be William H. Bonney.



DICK TURPIN
An infamous highwayman, Dick Turpin (1705–1739) robbed coaches on the busy roads near London. He tried to prevent his friend and fellow highwayman Tom King from being captured. In doing so, Turpin accidentally shot King, who later died.

MODERN BOUNTY HUNTERS

In this photograph, a modern-day bounty hunter catches a criminal in Miami. More than 100 years have passed since the legendary days of the Wild West. Although the preservation of law and order is now firmly in the hands of the FBI and local police forces, independent operators still work for reward money.

IN CUSTODY

Bounty hunting can still be lucrative. In the United States, if a person is arrested and offered bail, he can borrow the money, called a bail bond, from a bail bondsman for a fee. If the accused does not appear in court, the bondsman loses his money. This is when the bondsman puts bounty hunters on the fugitive's trail to recoup his money.

SHERIFF REEDER WEBB

In 1927, the Texas Bankers' Association published an announcement: "Reward \$5,000 for dead bank robbers, not one cent for live ones."

According to local legend, Reeder Webb, the sheriff of Odessa, West Texas, then lured two local thieves to a bank, where he shot them and collected the reward. To this day, a picture of Webb hangs in the sheriff's office in Odessa.

THE MAN WITH NO NAME

This still is from the 1964 western film *A Fistful of Dollars* in which Clint Eastwood played an honorable bounty hunter. In actuality, bounty hunters in the Wild West were often no more than hired killers, who would murder anyone for a "fistful of dollars."

Theft and burglary

Suitcases can be used to carry stolen goods from the property



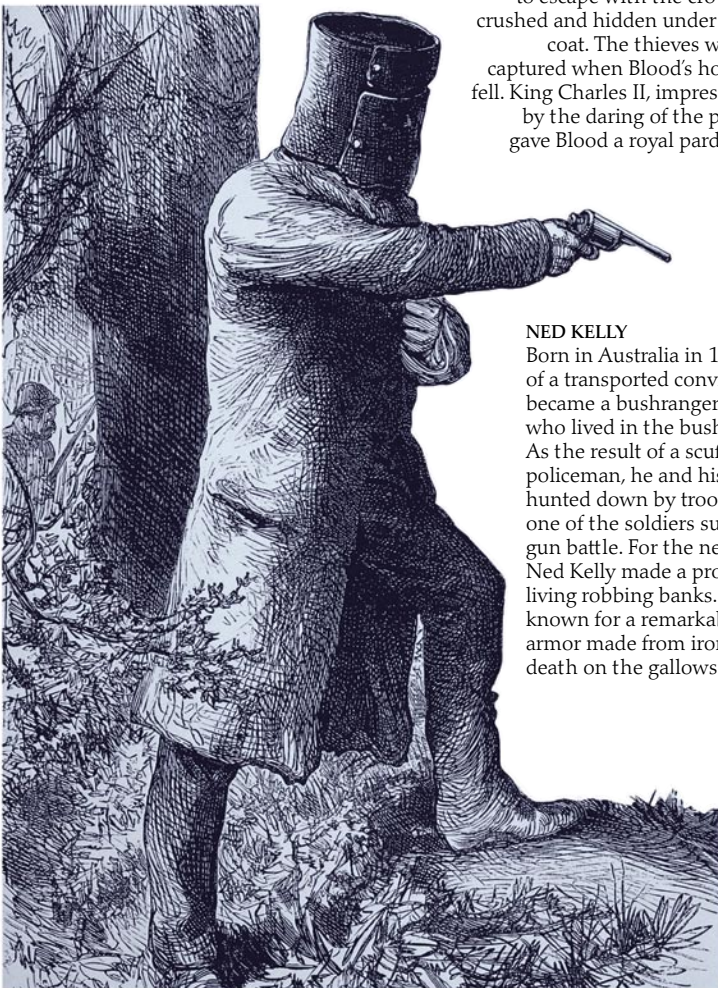
THEFT AND BURGLARY are classified as crimes against property. Theft covers everything from stealing an apple from a fruit stand to lifting a gold watch from a jeweler's counter. A theft is considered to be far more serious if it involves physical violence, as in the case of mugging. Burglary is entering a building for the purpose of stealing. It is considered a very serious crime, especially if the act is aggravated, for example, by the use of a gun.

MAKING A BREAK FOR IT

In 1950, a reformed burglar walked into the office of the English magazine *Picture Post* and offered to demonstrate his skills for an article on the methods used by a burglar. He staged a job and it was photographed. The former burglar stated that the general public, by failing to properly secure their homes, made burglary easy to commit.

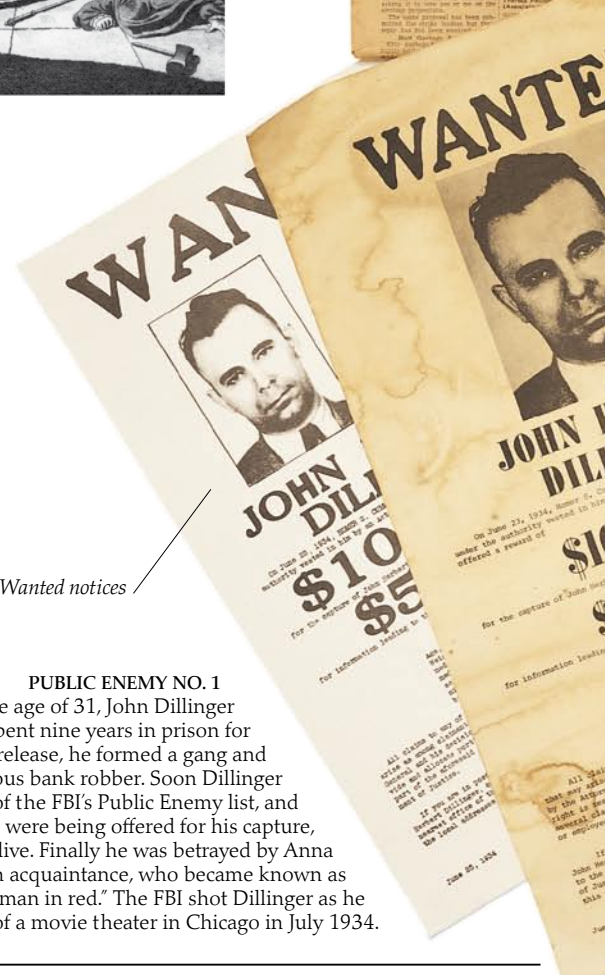
COLONEL BLOOD

In England in 1671, Irish adventurer Thomas Blood and two accomplices, disguised as clergymen, were allowed to see the crown jewels in the Tower of London. They attempted to steal them but found most of them too bulky and heavy. Blood managed to escape with the crown, crushed and hidden under his coat. The thieves were captured when Blood's horse fell. King Charles II, impressed by the daring of the plot, gave Blood a royal pardon.



NED KELLY

Born in Australia in 1855, the son of a transported convict, Ned became a bushranger, a robber who lived in the bush, or outback. As the result of a scuffle with a policeman, he and his gang were hunted down by troopers. Only one of the soldiers survived the gun battle. For the next two years, Ned Kelly made a profitable living robbing banks. He is known for a remarkable suit of armor made from iron. He met his death on the gallows in 1880.

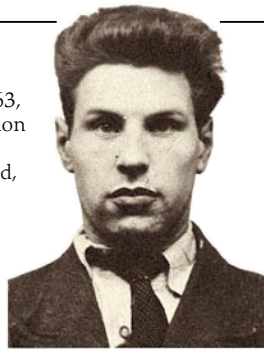
PUBLIC ENEMY NO. 1

In 1933, at the age of 31, John Dillinger had already spent nine years in prison for theft. On his release, he formed a gang and became a notorious bank robber. Soon Dillinger was at the top of the FBI's Public Enemy list, and huge rewards were being offered for his capture, dead or alive. Finally he was betrayed by Anna Sager, an acquaintance, who became known as "the woman in red." The FBI shot Dillinger as he walked out of a movie theater in Chicago in July 1934.

GREAT TRAIN ROBBERY
In the early hours of August 8, 1963, a gang of 12 robbers stole 2.5 million pounds from the Royal Mail train traveling between London, England, and Glasgow, Scotland. They hid out at a remote farmhouse before separating with their shares of the loot. Three of the gang got away. The rest, including the three pictured here, spent lengthy terms in prison.

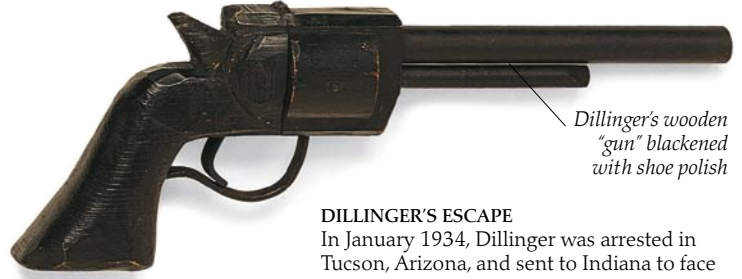

DILLINGER'S ESCAPE

In January 1934, Dillinger was arrested in Tucson, Arizona, and sent to Indiana to face charges of killing a policeman. Always a clever crook, Dillinger escaped from the jail in Crown Point by waving a "gun." In fact his weapon was simply a piece of wood carved into the shape of a gun. It could not have maimed anyone.

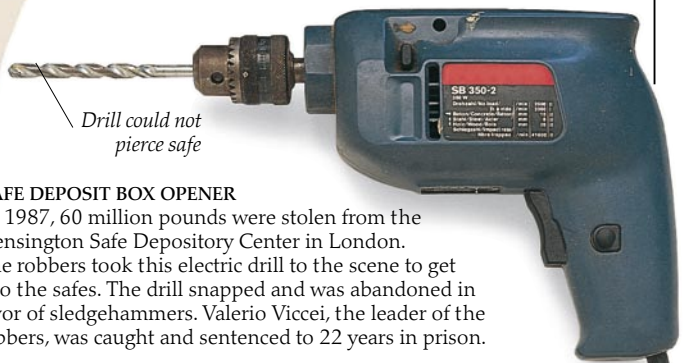


The forks can be levered up to here to allow the ram raiders to enter at a higher level



RAM RAIDING

A new threat hit the commercial and business world in the 1990s in the form of ram raiding. Vehicles fitted with fenders made from reinforced steel girders are rammed into doors and windows of shops and warehouses, breaking open an entry for robbers. The industrial vehicle shown above is perfect for the crime because of the forks at the front.



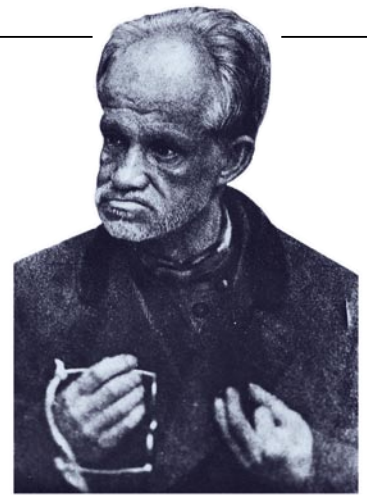

SAFE DEPOSIT BOX OPENER

In 1987, 60 million pounds were stolen from the Kensington Safe Depository Center in London. The robbers took this electric drill to the scene to get into the safes. The drill snapped and was abandoned in favor of sledgehammers. Valerio Viccei, the leader of the robbers, was caught and sentenced to 22 years in prison.

Swindles and frauds

THE WORLD IS A LARGE MARKETPLACE, with people selling goods and services and other people buying them. But this atmosphere of commerce has a dark side to it. Wherever there is a chance to make "easy" money by dishonest means, there are untrustworthy individuals ready to take that chance. And for every criminal, there is a person willing to believe that he or she can get something cheap. A swindle or a fraud involves deliberately cheating someone out of money. They range from cardsharps fixing games at fairs so there is no chance of winning, to con artists who have managed to "sell" public monuments for huge amounts of money.



CHARLIE PEACE
A burglar and murderer of the 19th century, Charlie Peace moved in respectable and wealthy circles. He was able to live this double life because he was a brilliant master of disguise. Even his own family could not recognize him in disguise.



FIXING SPORTS EVENTS
There are many ways to fix sports events, from paying a boxer to take a fall, or a football player to throw a game, to drugging horses to win or lose. Swindlers try to fix sports events because they can make huge amounts of money betting (or by taking bets from others) if they know in advance who is going to win. Most sports are regulated to try to prevent this sort of manipulation from taking place.

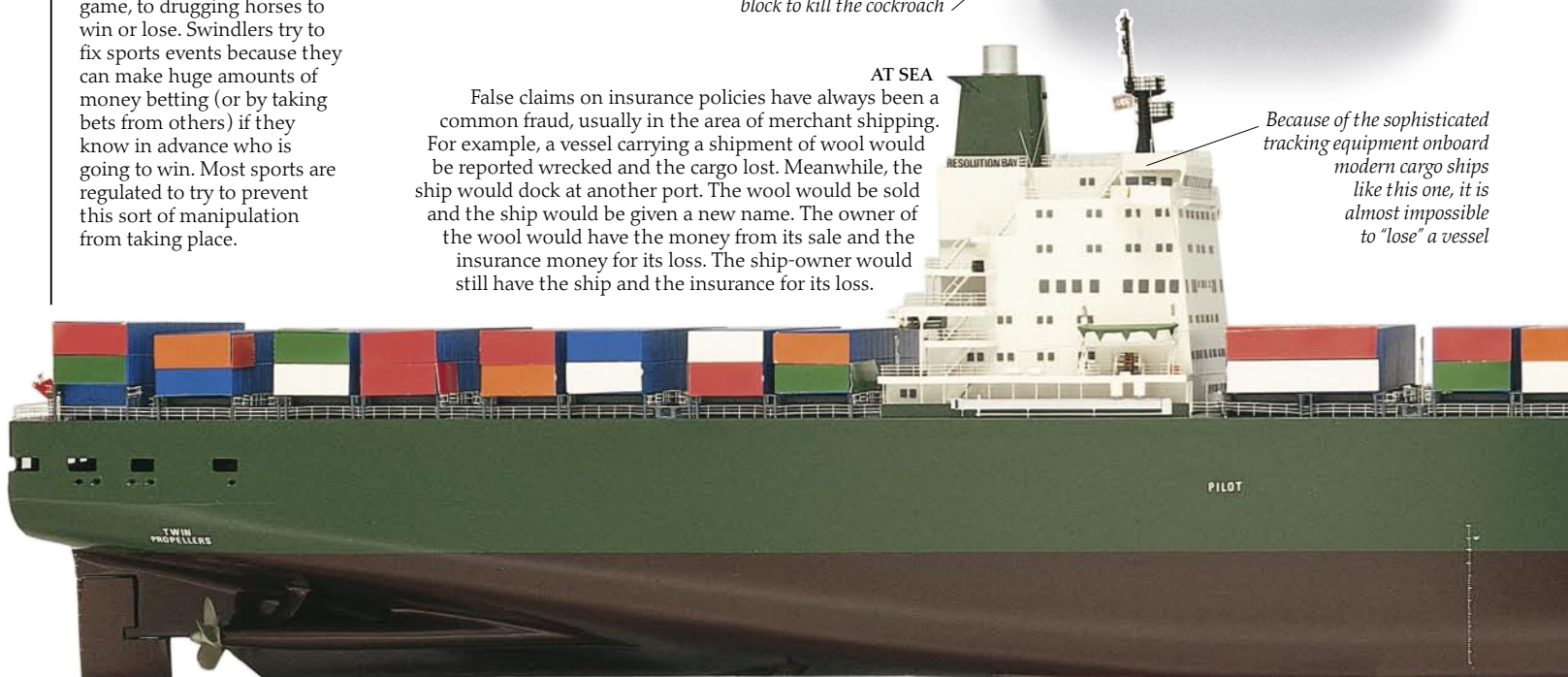
THE ULTIMATE BUG KILLER
Many swindlers do their business through newspaper advertisements. One ad published in a U.S. newspaper promised "a method 100% effective against cockroaches." People who sent money received two blocks of wood with the instructions: "Place cockroach on block A. Take block B and strike down hard on block A." AT SEA
False claims on insurance policies have always been a common fraud, usually in the area of merchant shipping. For example, a vessel carrying a shipment of wool would be reported wrecked and the cargo lost. Meanwhile, the ship would dock at another port. The wool would be sold and the ship would be given a new name. The owner of the wool would have the money from its sale and the insurance money for its loss. The ship-owner would still have the ship and the insurance for its loss.

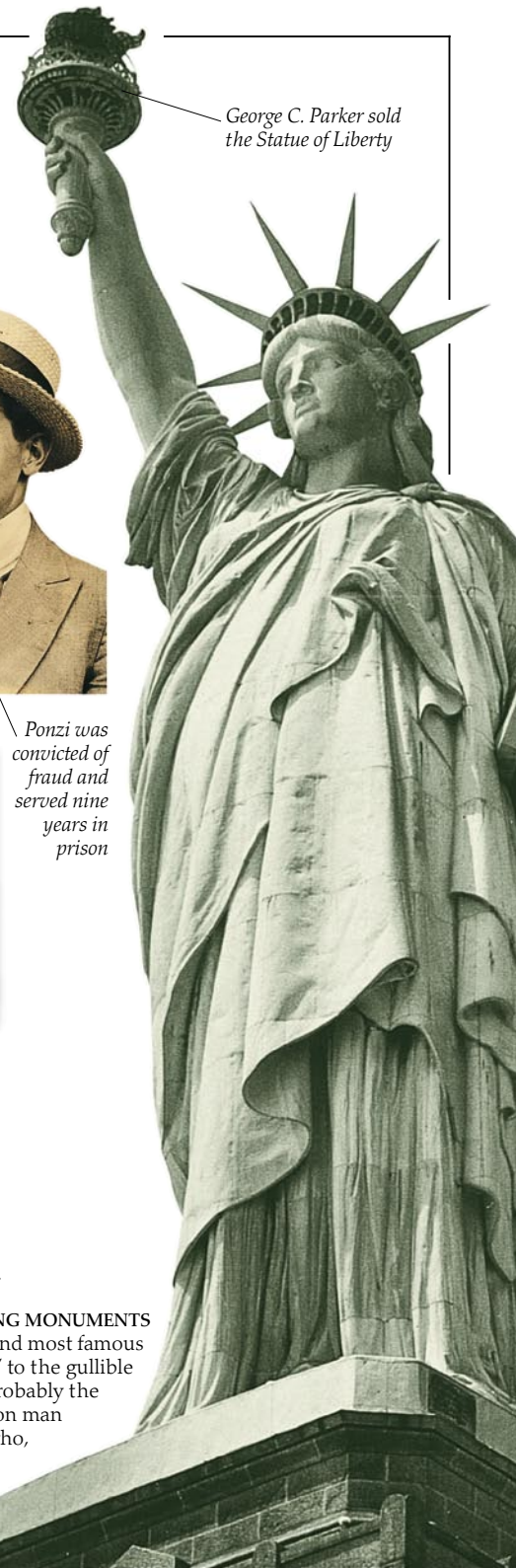
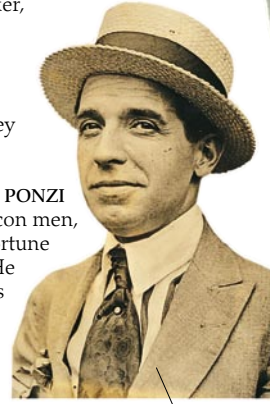


FIND THE LADY

"Find the lady" is a trick played at fairs or on the streets with three cards, one of which is the queen of hearts. The dealer lays the cards facedown on a table, first revealing which one is the queen. He then shuffles the cards on the table and invites the audience to "find the lady." The dealer's accomplice, pretending to be an ordinary onlooker, puts money on a card repeatedly, and wins. Then others try. But without having been briefed by the dealer, they cannot find the queen.

CHARLES PONZI

One of the world's most successful con men, Italian-born Charles Ponzi made a fortune in the United States in 1919-20. He persuaded people to invest money in his Financial Exchange Company with the promise of high interest. In fact, the company was not making any money. The interest it paid out was the money provided by new investors.

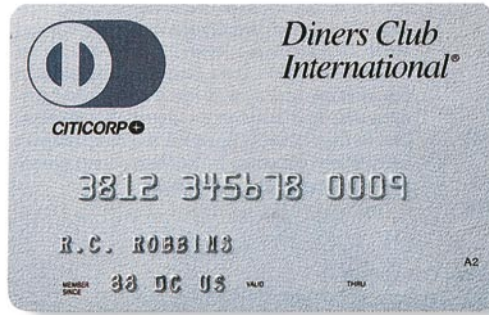

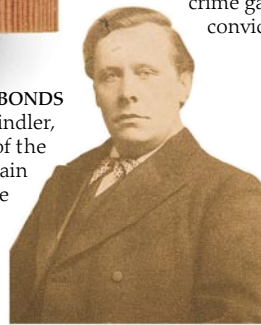


CREDIT CARD FRAUD

The most common form of credit card fraud is the use of stolen cards by thieves, but some schemes are more complex. For example, in the late 1960s, Alphonse Confessore, a maintenance engineer for Diners Club who used to make fraudulent charge cards for his friends, was blackmailed into printing 1,500 fraudulent Diners Club cards for an organized crime gang. Confessore was caught and convicted, then murdered as he left court.

VICTORY BONDS

Horatio Bottomley from England was a swindler, publisher, and politician. A self-styled "friend of the poor," he began the Victory Bond Club in Britain in 1919 to let poor people buy a share in the government's postwar investment. In fact, Bottomley was not investing the money, just keeping it for himself. He made £150,000 (\$240,000), was accused of fraud, convicted, and sentenced to seven years in prison.



SELLING MONUMENTS

Many of the world's largest and most famous monuments have been "sold" to the gullible by charming tricksters. Probably the greatest "monumental" con man was George C. Parker, who, over 45 years, sold the Brooklyn Bridge, Madison Square Garden, President Grant's tomb, and the Statue of Liberty.

Forgery

THE WORDS *forgery* and *counterfeit* are usually associated with paper money. However, anything that is rare or valuable is likely to be counterfeited, and can include items ranging from ancient Egyptian relics to modern "designer" perfumes. Forgery is usually attempted for profit, prestige, or political reasons. In the time of the Pharaohs, a group of Egyptians created a counterfeit Shabaka Stone, a relic thought to prove that the world was created in their capital city of Memphis. Some counterfeiters, such as those who forge works of art, do so solely to deceive experts. The advance of scientific techniques and instruments have made forgery more detectable than ever before, decreasing a counterfeiter's chance of success.



GUILTY GOLDEN EAGLES
 This pair of fake eagle brooches were made in the 19th century, sometimes known as the great age of faking. The eagle design was popular in the culture of the Visigoths, a Germanic people of the second through eighth centuries A.D. The originals were 4.72 in (12 cm) high and made of solid gold inlaid with precious gems. Several eagle brooches were analyzed and found to be cast bronze covered with gold sheet and inlaid with colored stones. In 1941, Amable Pozo, a Spanish jeweler, was revealed as the faker.

BILLY'S AND CHARLEY'S
 In the mid-19th century, Billy Smith and Charley Eaton sold genuine antiquities dug from the Thames foreshore. Demand was so great that they decided to make a few "antiquities" of their own, mostly "medieval" medallions cast in lead. Even after they were revealed as forgers, Billy and Charley continued in business until Charley's death.

CASTING A FORTUNE

Shabti were small figurines that were buried with the dead of ancient Egypt. They were to act as servants and carry out any tasks required of the deceased in the afterlife. Although some fakes have been cast from original shabti, many fakes have been made from scratch. They are easy to detect with their clumsy detail and incorrect hieroglyphic inscriptions.

PLATED FORGERIES

These fake ancient "gold" coins, claimed to be from the time of Alexander the Great, were cast in copper and plated in gold. The fraud was exposed only when the plating split to reveal the bright green color of oxidized copper.



THOMAS CHATTERTON
 Chatterton, born in 1752, began writing his own poetry while still at school in England. In 1768, he wrote a fake medieval text that was good enough to fool local experts. At the age of 18, he traveled to London and continued to write fake medieval poems and letters. When some of his work was revealed as fake, Chatterton lost both fame and fortune. He took his own life with arsenic in 1770.



COMMERCIAL FORGERY

There was a time when perfume was just perfume. One brand cost about the same as the next to produce. Now certain designer brands have become very desirable and, as a result, cost more than other fragrances. Poor-quality copies of expensive scents are made illegally and are popular.

COPYCAT CURRENCY

Forging currency can be very profitable. The forger can spend the counterfeit money or sell it to other criminals. The many precautions taken today, including paper quality, watermarks, numbering, elaborate engraving and printing processes, and security devices, make it more difficult to produce a forgery that can escape detection. But in earlier times, vast sums of forged currency circulated without detection.



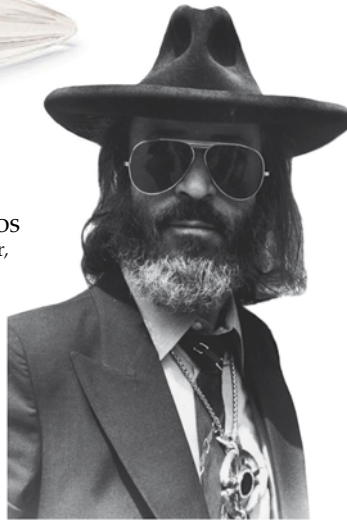

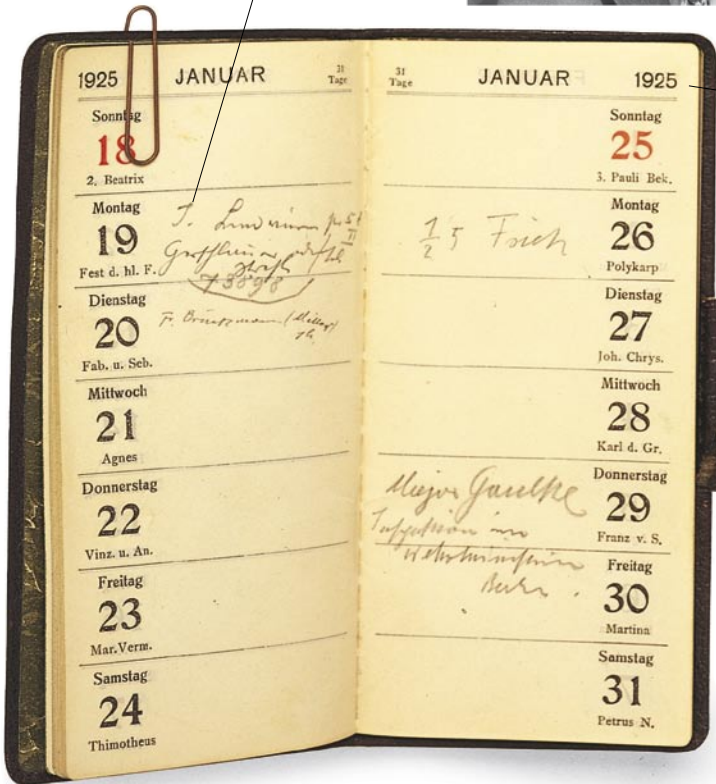

FERNAND LEGROS

Legros is an eccentric French art dealer, recognizable by his signature wide-brimmed hat, beard, and dark glasses. In 1967, he was accused of having sold fake masterpieces to a now-deceased Texas multimillionaire. The canvases were painted by Hungarian forger Elmyr de Hory, who later committed suicide.



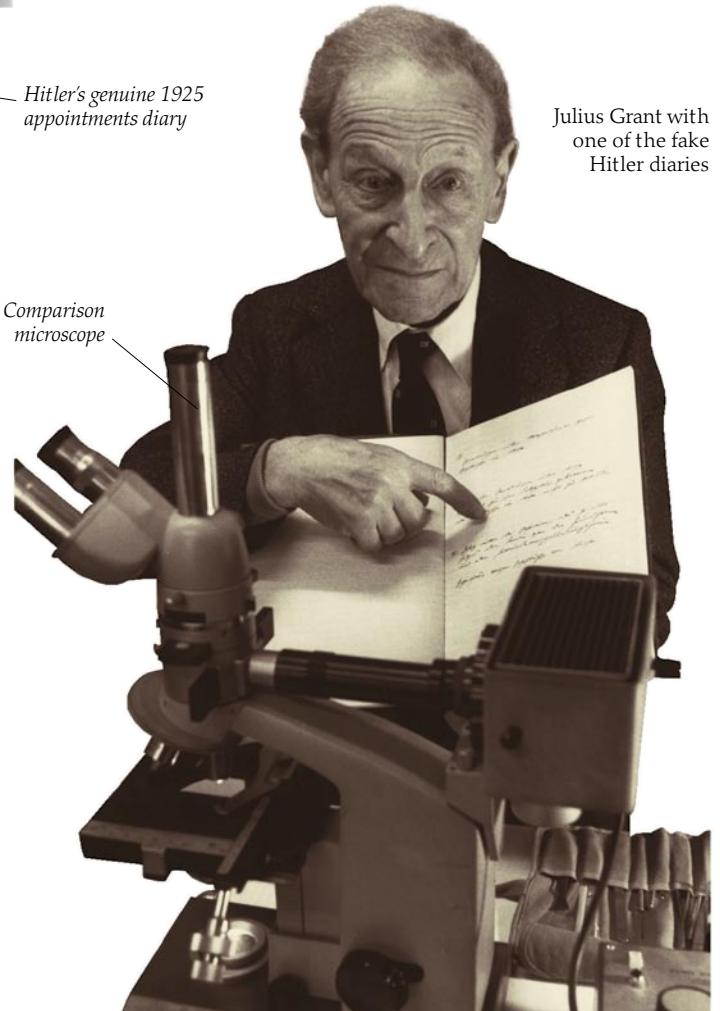

HITLER'S DIARIES

In 1983, the West German magazine *Stern* announced the discovery of the personal diaries of Adolf Hitler. Many experts lined up to authenticate them. Vast sums of money began to change hands for publication rights. Then Julius Grant, the foremost forensic document examiner of the century, inspected the documents. Grant soon determined that the paper on which the diaries were written contained optical dyes, which were not used in the manufacture of paper until after Hitler's death. Thus the diaries proved to be fakes.

Murder and kidnapping

PEOPLE HAVE BEEN harming and killing each other for property, power, or pleasure since the dawn of time. Other people have been trying to solve these crimes and capture the people responsible for them. As new technology has been developed, so the means of detecting crimes have improved. It is becoming more and more difficult to commit a murder or kidnapping without being caught, especially with advances in forensics (pp. 44–45), but it is often a criminal's own carelessness that leads to his or her apprehension.

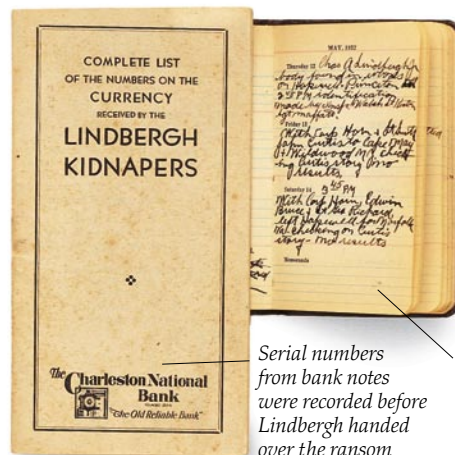


CAPTURE OF HAWLEY HARVEY CRIPPEN
After poisoning his wife in 1910, Crippen left London with his mistress, Ethel le Neve, on a ship bound for Canada. Despite the pair's disguises, the captain was suspicious and used the newly invented telegraph system to send a telegram to Scotland Yard. A detective overtook the fugitives on a faster ship and arrested them. Crippen was tried and hanged.



"ET TU, BRUTE?"

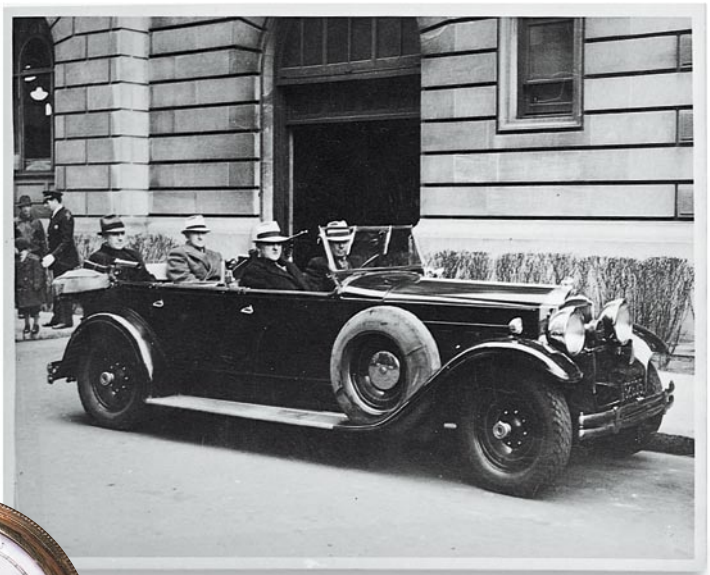
On March 15, 44 B.C., the Roman emperor Gaius Julius Caesar was stabbed to death in the Senate house by Marcus Brutus and other conspirators because they wanted to seize power. In one of the first triumphs of forensic medicine, Caesar's doctor Antistus was able to state that only one of the 23 stab wounds – the one through the emperor's heart – was fatal.



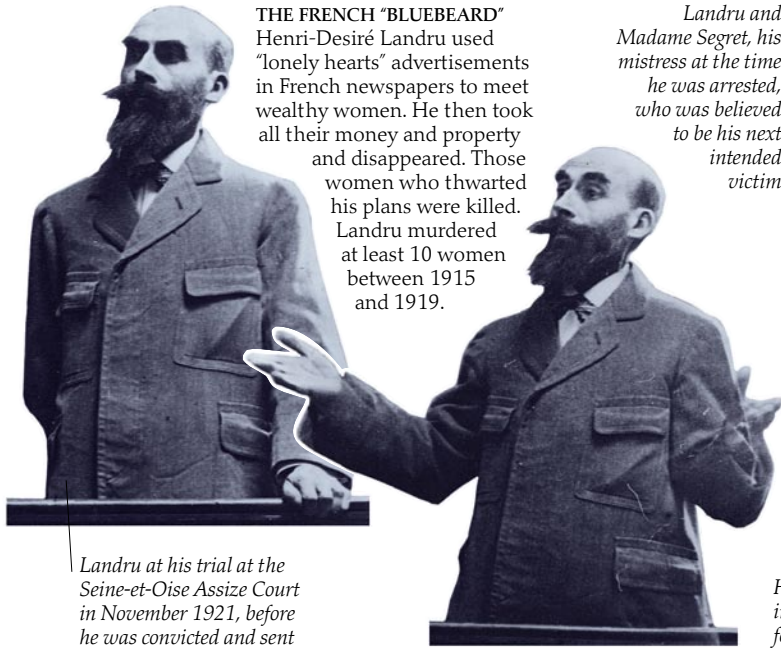

LINDBERGH ABDUCTION
In March 1932, a notorious baby kidnapping occurred. The baby's father, Charles Lindbergh, was the most famous aviator of his time. A ransom was paid, but on May 12, the infant's dead body was found. He had been killed soon after the abduction.

HAUPTMANN'S CAPTORS
In September 1934, FBI agents (above) learnt that some of Lindbergh's \$50,000 ransom money had been used at a New York gas station. The attendant had taken down the license plate number. This led to the arrest of a German-born carpenter named Bruno Hauptmann, who was later tried, found guilty of the child's murder, and executed in 1936.



THE FRENCH "BLUEBEARD"
 Henri-Desiré Landru used "lonely hearts" advertisements in French newspapers to meet wealthy women. He then took all their money and property and disappeared. Those women who thwarted his plans were killed. Landru murdered at least 10 women between 1915 and 1919.

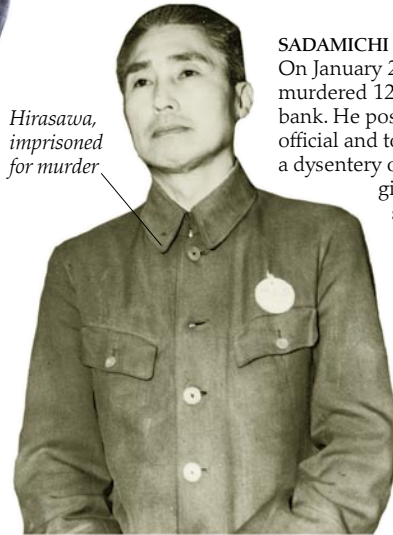

LEOPOLD AND LOEB

In 1924, Nathan Leopold and Richard Loeb, two American teenagers, tried to commit the perfect murder. On May 21, they stabbed 14-year-old Bobby Franks to death and sent his father a ransom note demanding \$10,000. Leopold's eyeglasses were dropped near the body. This and other evidence led to the pair's conviction. They were sentenced to life imprisonment for murder and 99 years for kidnapping.



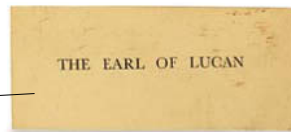

SADAMICHI HIRASAWA

On January 26, 1948, Sadamichi Hirasawa murdered 12 employees of a Tokyo, Japan, bank. He posed as a Health Department official and told the manager that, because of a dysentery outbreak, all employees must be given a dose of medicine. Within seconds of drinking the cyanide liquid, the bank staff died. Hirasawa fled with 180,000 yen.

WHERE IS "LUCKY" LUCAN?
 Richard John Bingham, Seventh Earl of Lucan, known as "Lucky" to his friends, disappeared on November 7, 1974. In the home of his former wife, he left the body of Sandra Rivett, his children's nanny. In June 1975, the coroner's jury announced a verdict of "murder by Lord Lucan." Although there have been reports from all over the world that Lord Lucan has been seen alive, the sightings have never been confirmed. His fate remains a mystery!

Prohibition

ON OCTOBER 28, 1919, the U.S. Congress passed the National Prohibition Act, commonly known as the Volstead Act, which made the sale of alcoholic liquor illegal. At first it was a popular act, but soon it was evident that Prohibition was both absurd and unworkable. People who rarely drank became desperate to do so; people who drank a lot demanded more. This demand was being met by organized gangs who had discovered that huge amounts of money could be made. Ships carried cases of spirits to the United States from all over the world. A \$15 case of smuggled whisky would be sold for \$80. Rivalry between gangs was fierce and often erupted into violence in the streets.



AL "SCARFACE" CAPONE
Alphonse Capone, most notorious of the Chicago gangsters, began his career in crime in New York. In 1919, he took control of illegal alcohol distribution in Chicago. It is claimed that Capone, with 300 gunmen, was responsible for 1,000 killings.

HIDING THE LIQUOR

Soon the gangs found they could make more cash by manufacturing and selling their own alcohol (bootlegging), and there was less risk involved. However, many people tired of the excessive profits made by the gangsters and decided they too could make their own, known as "bathtub gin." It was not until 1933 that Prohibition was repealed.

THE UNTOUCHABLES

Eliot Ness, born in 1902, became well known during the late 1920s as a special agent in the Prohibition Bureau of the U.S. Department of Justice. He led a team of officers, called "The Untouchables" because they could not be bribed or intimidated by gangsters, to break up the trade in illegal alcohol.

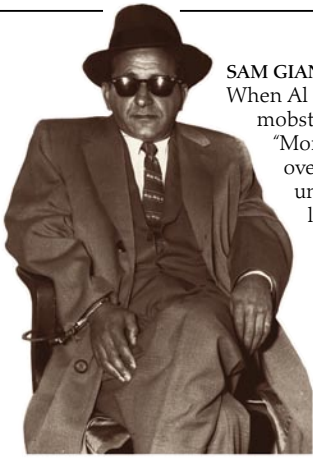


HOOVER

John Edgar Hoover rose through the ranks of the U.S.

Department of Justice to become the first director of the Federal Bureau of Investigation (FBI) in 1924. During the 1930s, he attacked the problem of gangsterism and started a list of "Public Enemies." Hoover headed the FBI for 48 years, under eight presidents.





SAM GIANCANA
When Al Capone died, other mobsters, including Sam "Momo" Giancana, took over the Chicago underworld. Giancana later became the city's crime boss. He moved into gambling clubs and ended up with a large share of the Riviera Casino.

GIANCANA'S JEWELRY

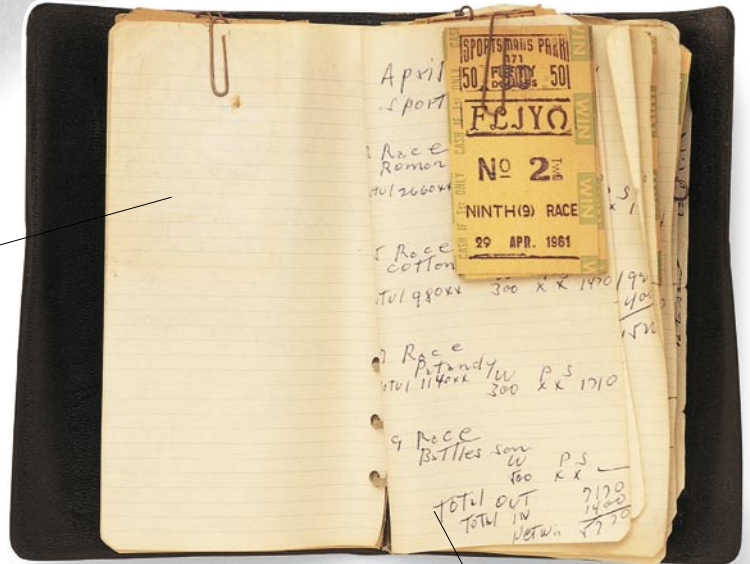
Giancana's jewelry was confiscated and returned by the law when he was arrested many times. Before the age of 20, he had been arrested three times for murder. When he took command of the Chicago Mafia, he had been arrested 60 times for charges including battery, bombing, and assault to kill. He was described as the most ruthless mobster in the United States. He was murdered in his home in 1975.

CONCEALED THREATS

For obvious reasons, gangsters preferred to conceal their weapons when traveling to a "job." The most popular hiding place for shotguns and the Thompson submachine gun, or tommy gun, was a violin case. It proved surprisingly successful despite the fact that a group of "Big Al's" hoodlums were not likely to pass as the string section of the Chicago Philharmonic!

FRANK COSTELLO

Frank Costello rose through the gangster world to control much of the country's gambling. In 1951, he was a star witness at the Kefauver Investigation. Despite the extent of his gangland crime, Costello, like Capone, was finally jailed for tax evasion.

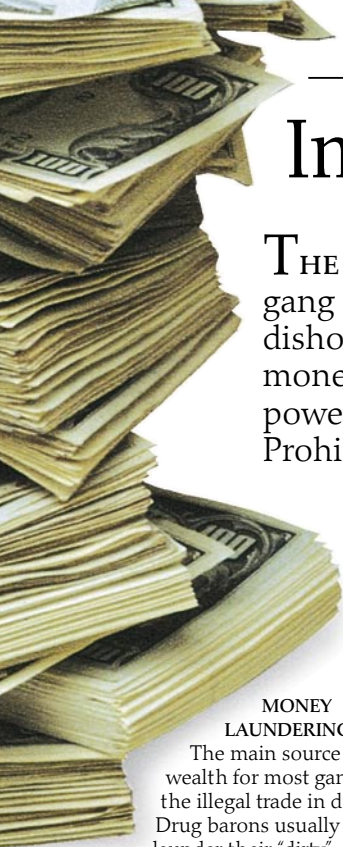


KEFAUVER HEARINGS

The televised hearings were opened in May 1950 by Tennessee's Senator Estes Kefauver. The five-man committee spent almost two years traveling the United States interviewing hundreds of underworld figures to determine whether there was any evidence that an organized crime syndicate was in operation. Their conclusion was that such a network did exist.

International gangsters

THE MAFIA IS PROBABLY THE BEST-KNOWN organized crime gang in the world, but it is not the only one. Wherever dishonest money can be made from drugs, gambling, and moneylending, gangsters organize themselves into powerful groups to lay claim to it. Like the mobsters of Prohibition times, modern gangsters defend their territory jealously, and often violently, and new territories are constantly established. For example, the Triads, which originated in China, now have units all around the world. However, there have been great changes in the way that these modern criminals operate. Gangsters often look more like bank managers than hoodlums, and many have come to realize that there is a considerable advantage in running a respectable business to act as a cover for their dishonest deals.



MONEY LAUNDERING

The main source of wealth for most gangs is the illegal trade in drugs. Drug barons usually launder their "dirty" money by filtering the cash through large "respectable" companies and banks owned or run by the gangs.



MAFIA NUN
Sister Alvina Murelli, a 51-year-old nun, was arrested in 1983, in Naples, Italy, when police began a crackdown on the underworld of organized crime gangs. In the photo above, she holds a copy of the New Testament's four Gospels. She used this book to smuggle out coded messages from the mafiosi whom she visited in jail.

GAMBLING

Like the drug trade, illegal gambling is a popular source of gangland money. It provides very big returns for very little outlay, and the chances of winning are stacked against the player even if the game has not been fixed. Chinese games of chance figure very strongly in the Triad economy, and illegal basement gambling dens can be found in Chinatown districts around the world.

YAKUZA FUNERAL

The Yakuza controls most of the gangland activity in Japan. Although the members claim to have a Robin Hood image – robbing the rich to give to the poor – the Yakuza was officially outlawed in 1992 for its activities in the areas of extortion, money laundering, and gunrunning. In 1984, Masahisa Takenaka, leader of the Yamaguchigumi (largest of the Yakuza gangs), was killed by rivals. His funeral (left) was attended by members of the group – and 400 riot police.

CAPTURING GANGSTERS
Enhanced communications systems around the globe have increased the efficiency and success rate of most of the world's police forces. In 1996, the arrest of Sicilian bomber Giovanni Brusca ended one of Italy's most intensive manhunts and marked a significant victory against the growing threat of organized crime in Sicily and Italy.

SECRET HIDEAWAYS

Communication among Mafia bosses has also improved over the years, and many meetings are held to arrange "business" deals. In 1985, Italian police broke into caves under the country villa of Michele Greco, a top Mafia leader in Sicily. Mafia leaders held summit meetings in this underground hideaway.



"RUSSIAN MAFIA"

In the confusion and disarray following the breakup of the former Soviet Union, organized crime moved in. Known as the "Russian mafia," the gangs have become ruthless, violent and increasingly bold. This violence has been met with equal brutality by the police - resulting in many funerals, such as that of mobster Vladislav Listiev (above).

ALL ON THE SPIN OF A WHEEL

One of the most popular gambling games in the big casinos is roulette. For decades, organized crime has made easy money at the roulette wheel, where corrupt casino owners run rigged games. Most of the profitable betting games, however, are card games, such as blackjack, poker, and faro.

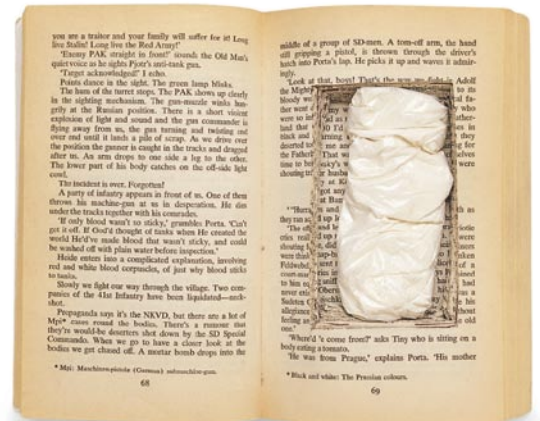

Smuggling and piracy

SMUGGLING IS THE ILLEGAL MOVEMENT of goods in and out of countries. It is an extremely profitable crime because the smuggler avoids paying customs duties on these items. Customs duties are taxes on certain goods, such as tobacco or alcohol, that are imported into the country. There is also a profit to be made when smuggling items or substances that are banned, such as illegal drugs like cocaine and marijuana, from one country to another. Piracy, or robbery at sea, has occurred since ancient times, and involves the capture of wealth or vessels on the open seas.



OLDEST TRICK IN THE BOOK
An old method of smuggling small amounts of illegal goods is to hide them inside a hollowed-out section of a book. Another method is replacing a legal substance, such as talcum powder, with a similar-looking illegal drug.

CUSTOMS OFFICERS
Port police officers, such as these French officers in 1905 (above), are called customs officers and work to prevent smuggling. Alcohol and tobacco used to be commonly smuggled substances. Now drugs are a customs officer's main concerns.

FACE THE WALL
It was customary for villagers of the south coast of England during the 18th century to turn their faces to the wall when smugglers carried contraband from their boats. This way, the locals could not identify the smugglers when questioned by customs officers. Identification would both anger the smugglers and deprive the locals of the smuggled goods.

ON THE EDGE OF EXTINCTION
As a result of the continuing threat to endangered wildlife, international agreements have been signed to outlaw the killing of certain birds and animals. Also banned are the export of some live creatures and the trade in animal parts, such as skins, ivory, and bones. The exquisite shell of the hawksbill turtle (left) is sold illegally as a curiosity or for making into souvenirs such as jewelry boxes.

SKIN OF THE JAGUAR
The jaguar is killed illegally for its coat. This skin was seized by authorities in Brazil. In many parts of the world, trade in illegal animal products provides an income that is vital for human survival. Where conservation is most needed, poverty is often greatest.





ALWAYS ON ALERT

Smuggling is only one of the crimes that air transport police must try to prevent. Others include terrorism and large-scale theft from the airport's secure warehouses. Airports are policed by armed security officers.

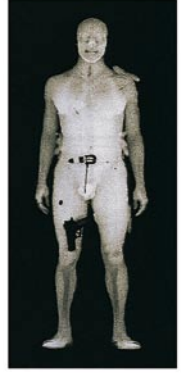


BAG CHECKING

While armed officers secure the safety of a seaport or airport, customs officers inspect passengers' baggage for smuggled goods. They usually do not check every suitcase or bag, but rely on experience, instinct, or tips (advance information) to pick out bags likely to contain smuggled goods.

X-RAY VISION

In an attempt to reduce international terrorism and smuggling, officers use equipment that can scan human beings and their luggage for concealed objects, such as guns. This device has detected bags of cocaine, knives (plastic and metal), coins, and guns.

HIDING THE GOODS

Getting contraband (smuggled goods) past the watchful eyes of customs officers is the smuggler's most difficult task. Countless objects have been used to conceal forbidden contraband – from hollowed-out books and statues to shoes and spare tires.

PIRATES

A gang of Chinese pirates (above) climb aboard to attack a ship. Pirates were not the romantic characters portrayed in literature and films. They were murderous robbers who often fought among themselves and stole from each other.



Fire!

MOST FIRES START ACCIDENTALLY – a cigarette is left burning, or a stove is left on. Arson fires, however, are started deliberately. Whatever the cause of the fire, the procedure to put it out is the same. Most countries have emergency fire departments. When the firefighters arrive at the scene, they must make sure that any occupants are taken to safety, put out the fire, and ensure that the building is safe from collapse. If there has been any loss of life, or if the fire seems to have been started deliberately, a fire investigation unit moves in. If arson is suspected because, for example, traces of gasoline have been found, the fire investigation unit works closely with the regular police force to solve the crime.

FIGHTING THE FIRE

Firefighters belong to one of the most dangerous of the emergency services. At each major incident there are three major hazards – fire and explosion, smoke inhalation, and falling debris. The firefighters' skill is enhanced by the use of well-equipped vehicles and advanced protective clothing.

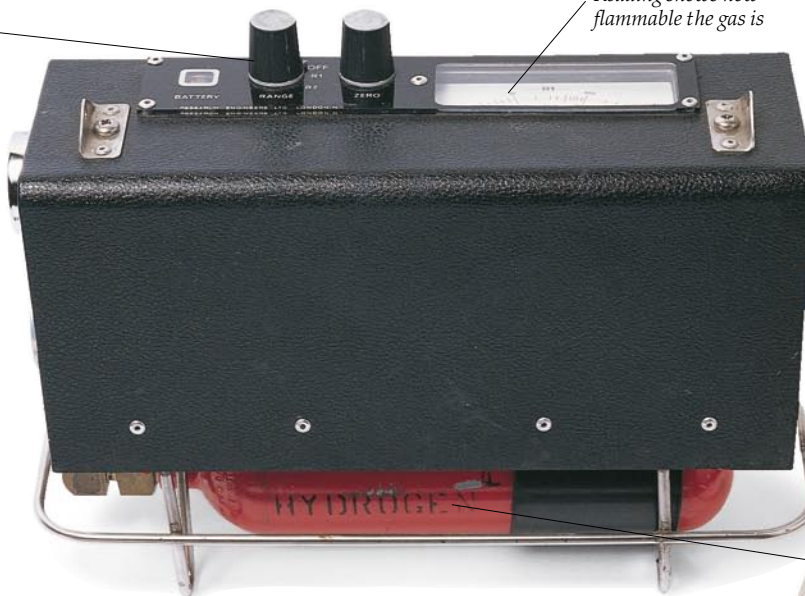

SAMPLE COLLECTION
Collecting clues is vital to the success of any investigation. Because contaminated samples are useless for analysis in the forensic laboratory (pp. 46–47), officers carry glass jars in which to store and protect evidence.

TESTING THE AIR FOR GASES

Once the fire is out, the fire investigation unit tries to find the cause. The hydrogen flame tester is used to detect the presence of flammable gases at the scene of a fire. Once it is established that a flammable gas is present, the gas can be identified and the cause of the fire determined. Within the machine, there is a naked hydrogen flame. Gas is sucked in and passes over this flame. The flame increases if the gas is flammable, and this increase is translated into a meter reading.

The degree of flammability indicates the nature of the gas.

REASONS FOR ARSON
 There are three main reasons for arson. The fire may disguise some other crime, such as robbery or murder. It may be started as an act of revenge. However, most arson attacks are associated with fraud. The number of arson fires rose during the Great Depression in the United States in the 1930s as financially troubled businesses burned their property to collect insurance payments.

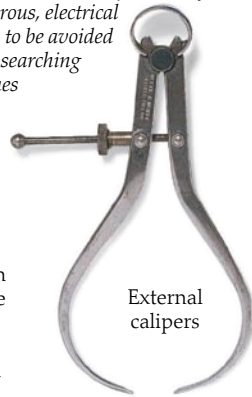

TAKING MEASUREMENTS

The accurate recording of a crime scene is essential to all investigations. This is especially important in the case of arson, where buildings may have to be quickly demolished for safety reasons. Measurements indicate the size and dimension of a location and the distance between objects. By comparing these measurements to the extent of fire damage, the officers can determine the speed and nature of the fires. A number of specialized measuring tools have been developed to give very accurate results. The sonic measurer sends sonic rays from one surface to another, measuring the distance in between.

PORTABLE GAS ALARM

The portable gas alarm detects gases in the air before they are present in large enough quantities to be a fire risk. It is used in work environments that are prone to leaking toxic gases, and also by fire investigation units to ensure that the atmosphere in which they are working is safe. The hydrogen flame tester (left) is not used until it has been established that there is not enough gas in the air to cause an explosion when the naked flame is lit.

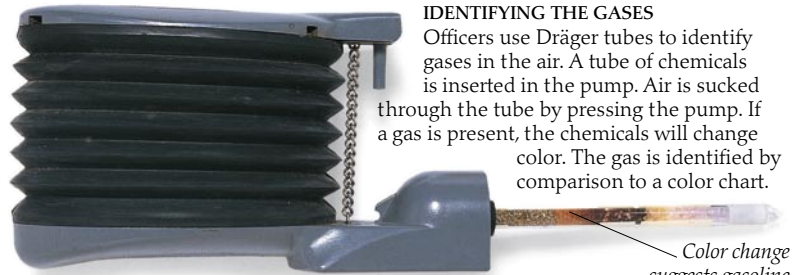
HEDGEHOG DISASTER

In Germany in 1954, Dr. Müller and his wife were driving home. Müller claimed that while he left the car to remove a hedgehog from the road, the vehicle burst into flames, killing his wife. Remains of a gasoline can found in the car and proof that Müller had been having a love affair suggested arson. Müller was found guilty of murder and sentenced to six years in prison.



IDENTIFYING THE GASES

Officers use Dräger tubes to identify gases in the air. A tube of chemicals is inserted in the pump. Air is sucked through the tube by pressing the pump. If a gas is present, the chemicals will change color. The gas is identified by comparison to a color chart.

FINDING THE SOURCE OF THE FIRE

If the fire investigation unit suspects that the fire was started deliberately, a scene-of-crime officer who specializes in cases of arson is brought in. Since fires spread upward, the officer will begin at the lowest point to find the source of the fire. These officers are looking for clues near a window where an arsonist may have entered or left the building.

Police uniforms

THERE ARE TWO IMPORTANT reasons why police officers wear uniforms: first, so they can be recognized by members of the public who need assistance, and by suspects being pursued; and second, so they can identify each other and be identified by other emergency service personnel, such as firefighters, at the scene of an incident. Because climates differ throughout the world, police in different forces have different uniforms. However, all uniforms are designed to be comfortable and functional while still being formal.

MOUNTIES

This uniform is worn by a British woman police constable (WPC). The first female officers appeared on the streets in 1919, following the success of their voluntary patrols during World War I. Police agencies

MOST PEOPLE THINK of police as either uniformed patrol officers who keep the peace on the world's streets or detectives who solve serious crimes. In fact, police forces include many specialized units formed to operate in special circumstances and conditions. Some squads, such as the Japanese riot police, the French *Compagnies Republicaines de Securité* (CRS), and the U.S. Special Weapons and Tactics (SWAT) units, are trained to deal with difficult violent situations. Some squads use specialized vehicles, such as helicopters, boats, motorcycles, or horses, to perform their job under unusual conditions. The overall aim is to develop a chain of interdependent units to combat crime.



ON THE BEAT

A community's safety and well-being are usually in the hands of the "beat" officers such as the French policeman here. A beat police officer patrols the streets on foot or in a vehicle, preventing crime and protecting citizens' rights to a crime-free society.

CROWD CONTROL

In any situation where rioting crowds cannot be managed by regular police, specially trained and equipped officers are sent to the scene to restore order. In Japan, the riot police squad (above) is known for its efficiency.



HIGHWAY PATROL

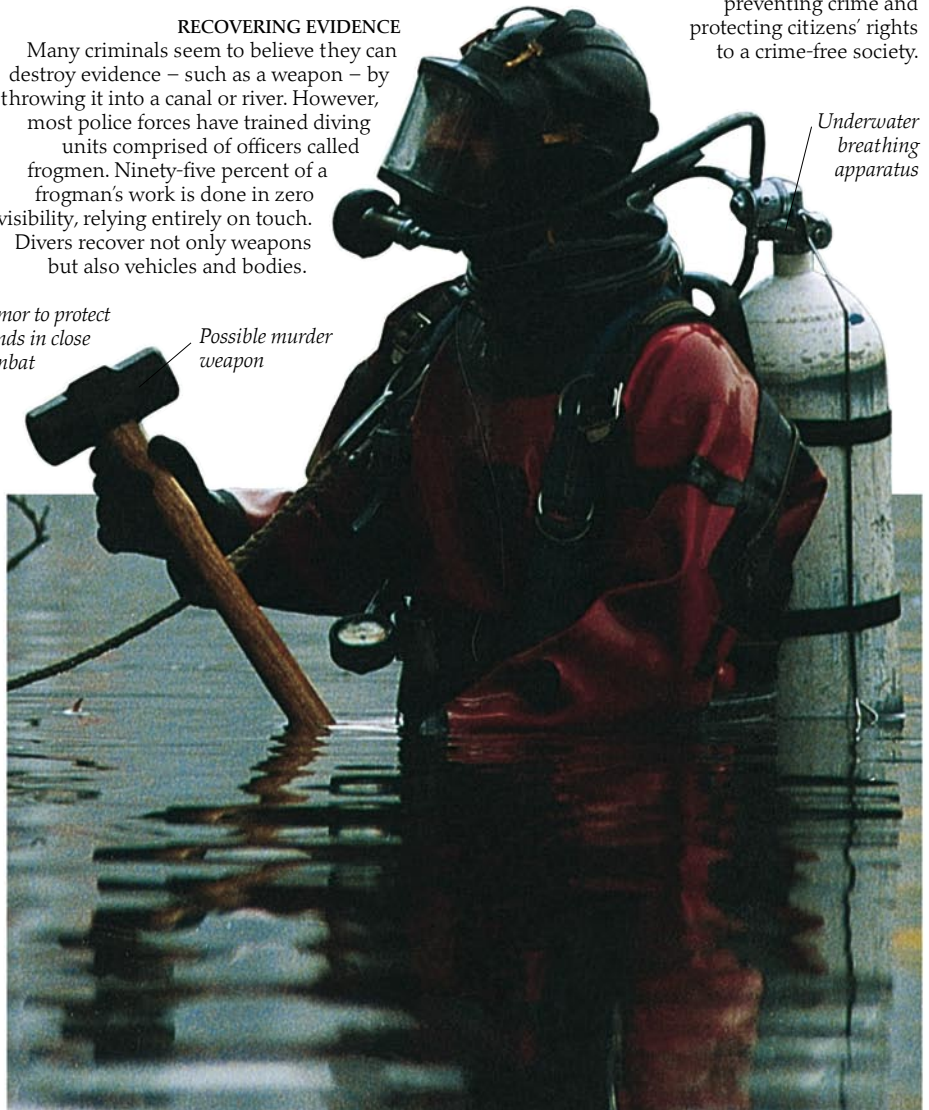
High speed and maneuverability have made motorcycles an essential vehicle for the police. Most forces have trained motorcycle units, such as the Los Angeles traffic police (left), who patrol the highways and city streets.

RECOVERING EVIDENCE

Many criminals seem to believe they can destroy evidence – such as a weapon – by throwing it into a canal or river. However, most police forces have trained diving units comprised of officers called frogmen. Ninety-five percent of a frogman's work is done in zero visibility, relying entirely on touch. Divers recover not only weapons but also vehicles and bodies.

POLICE MARKSMEN
Officers highly trained in the use of firearms work with the regular police in sieges or hostage situations. The order to shoot to kill is only given when all other options have failed, as there is always a chance of hitting a civilian. These special armed units are separate from the many officers throughout the world who routinely carry guns.



MOUNTAIN RESCUE
Special police teams with climbing experience are used in some mountain areas to help with rescue work. The officers (above) work in the French Alps where they use motorcycles to travel quickly over rough ground. The motorcycles are much lighter than those used in highway patrol, similar to the trail bikes used in cross-country racing.

MOUNTED POLICE
Many countries have a mounted police branch, usually used to control crowds and to perform ceremonial duties. The first British horse patrol was a pair of mounted Bow Street Runners (p. 10) in 1763. In 1805, a larger patrol was introduced. Because of the color of their jackets, the officers were called "Robin Redbreasts." Today London's Metropolitan Police has a patrol of about 200 horses. A female rider is shown here (right).



CANADIAN MOUNTIES
The Royal Canadian Mounted Police was founded in 1873 as the North West Mounted Police, then renamed in 1920. The Mounties patrolled the vast prairies in the west. The intelligence and sure-footedness of the horse made it a perfect means of transport. Even today, the horse is a valuable asset.

SIR ARTHUR CONAN DOYLE
Probably the world's best-known fictional detective is Sherlock Holmes, created in the 1880s by Sir Arthur Conan Doyle (1859–1930), a British writer. Holmes relied on logical deduction and attention to minute detail to solve crimes. It is less well known that Conan Doyle was also an amateur sleuth himself, and was involved in a number of major cases.

Detectives

THE TASKS OF INVESTIGATING a crime and identifying the culprit are carried out by detectives. Whether by interviewing witnesses or searching for the tiniest piece of forensic evidence, detectives try to reconstruct a sequence of events until they believe they know what happened. Most detectives are officers in a specialized division of the police, but many others work for private agencies. These detectives, who are often known as private investigators (PI's), can be hired by anybody to investigate anything – for a fee. The public's fascination with the detection of crime is reflected in the number of detective stories in books and on film and television. These detectives may be real or fictional characters, and their methods and equipment may differ, but they share a common pursuit: the fight against crime.

TAKING A CLOSE LOOK
Sometimes the smallest detail provides the clue that solves a crime, which is why the ability to magnify objects is so important in detection. In the laboratory, microscopes are among the most valuable pieces of equipment. Binoculars are also useful to detectives on surveillance, who must be able to see activities and people clearly without being noticed themselves.

MAIGRET
Popular French detective Commissaire Jules Maigret of the Police Judiciaire is the main character of dozens of novels, short stories, films, and television programs. Maigret was created in 1930 by Georges Simenon, a Belgian-born writer, and has always been identifiable by his trademark pipe.



INTERNATIONAL AGENCY
Police forces around the world are centralized at Interpol (the International Criminal Police Organization), established in 1923. Police detectives can refer to computer files, fingerprints, and criminal records gathered from more than 100 member countries. Interpol's headquarters have been in Lyon, France, since 1989.



PHILIP MARLOWE

A familiar character in detective fiction is the hard-boiled, tough-talking private eye who lives a lonely life on the city's "mean streets." Philip Marlowe, created in the 1930s by Raymond Chandler, is perhaps the best-known example of the type, immortalized in novels and films.



MRS. KERNER

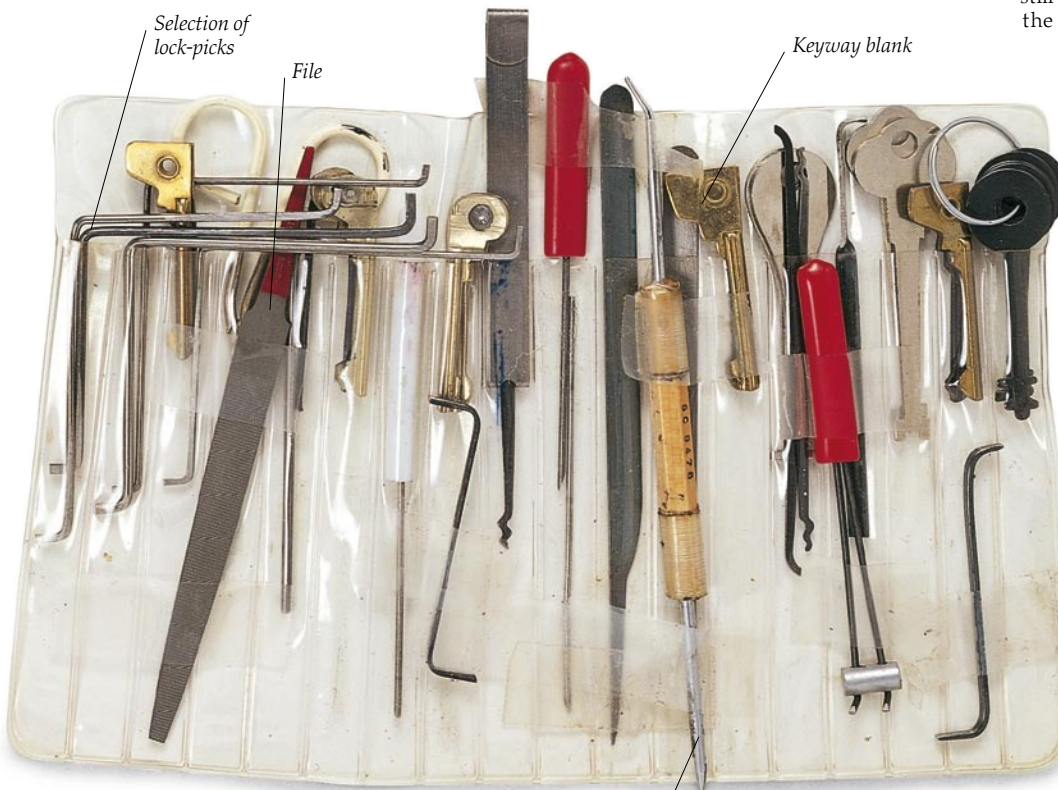
Annette Kerner, Britain's most famous female private detective, worked from the early 1920s to the 1950s. She became known as "the queen of disguise" and was equally convincing as a waitress in a criminals' café as she was as a socialite while thwarting a jewel theft. She once posed as a drug addict to catch a gang of opium dealers.

PRIVATE EYES THAT NEVER SLEEP

In 1850, U.S. detective Allan Pinkerton established the organization that has become the world's oldest privately owned detective agency – it is still going strong. The term *private eye* came from the Pinkerton trademark – the words "We Never Sleep" written under an open eye.



USING CRIME AGAINST CRIMINALS

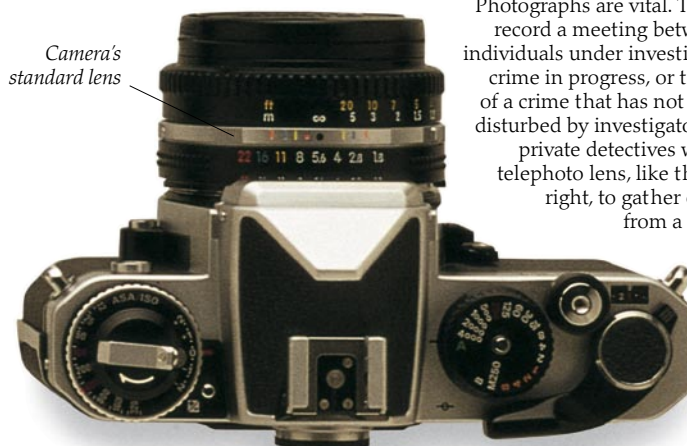
It is not only burglars who find it useful to have a set of tools to open locks. Many detectives and undercover surveillance officers also need to get past locked doors – perhaps in the search for drugs, stolen goods, or information about a crime. The official equipment shown at left can open most kinds of locks, almost anywhere in the world.

Estelle Roberts was a famous English "psychic detective" who worked with the police. If given a victim's personal objects from the crime, Roberts could sometimes imagine the crime scene in her head, even seeing the criminal's face.



RECORDING EVIDENCE

All investigations involve the collection of a wide range of clues. Photographs are vital. They may record a meeting between the individuals under investigation, a crime in progress, or the scene of a crime that has not yet been disturbed by investigators. Most private detectives will use a telephoto lens, like the one at right, to gather evidence from a distance.

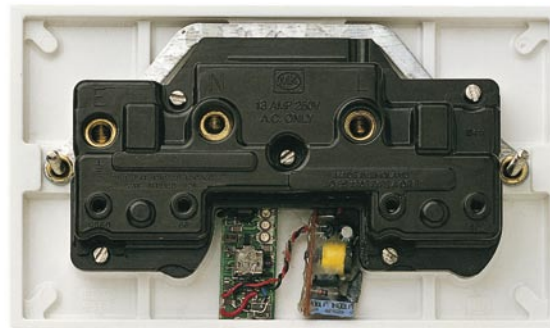
INFORMATION IS VITAL to both the person who wants to commit a crime and the person who wants to catch the criminal. For example, the time at which a bank transfers money is as important to the bank robber as the time of a planned raid is to the law enforcement officer. In the early days of detective work, information-gathering techniques were simple. The robber, sometimes working with an accomplice inside the bank, watched and waited. The officer, with the help of informants, did the same. Today's great technological advances, however, have made the gathering of secret information easier than ever. With round-the-clock observation on closed-circuit television, telephone tapping using tiny transmitters, and advanced tracking systems that lead detectives to the thief, criminals may be seen, heard, and traced through every stage of their crimes.



THE EVER-OPEN EYE
The use of closed-circuit television (CCTV) is vital in the fight against crime. Signals are transmitted from a camera to a television screen along cables or telephone links, in a closed circuit. Cameras placed in areas such as stores and banks can provide police with accurate records of crimes being committed and lead to visual identification of the perpetrators. The introduction of CCTV in courtrooms allows some witnesses, such as young children, to be interviewed in a separate room with a live video replay in the courtroom.

WIRED FOR SOUND

This battery-operated bug (below left) is the size of a matchbox. The device, which consists of a microphone attached to a radio transmitter, is hidden. Sound signals from the bug are picked up by the radio receiver (below right), which transfers the signals to an earpiece.



A BUGGED ELECTRIC SOCKET

This electric socket looks like any other. Even with the cover removed, the miniature bugging device is not visible. The device is a transmitter that carries sound in the room, in the form of radio waves, to a distant receiving unit. Another kind of device transmits sound directly along the power cable to a receiver plugged into the same electrical circuit.

CONCEALED CAMERA

This canvas shoulder bag has been adapted to hide a video camera. One of the fasteners has been removed, leaving a hole. The camera is carefully placed inside the bag so that the lens is positioned next to the hole. The concealed camera can then secretly record images from within the bag.

HIGH-TECH PURSE

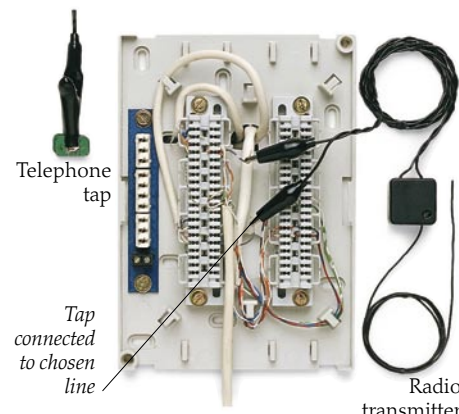


STAKEOUT

A stakeout is an undercover surveillance operation. In this still from the film *Stakeout*, actor Richard Dreyfuss portrays a detective keeping watch. He uses binoculars, wiretaps, and other classic devices to keep crucial witnesses and suspects under surveillance.

ULTRAVIOLET DETECTOR KIT

One way to fool burglars is to mark valuable goods with a substance that is invisible under normal lighting but that shows up clearly under ultraviolet light. The thief's hands are covered with the substance after handling the goods. Another method is to use a substance that is colorless until it mixes with water. The thief touches the goods and unwittingly covers his or her hands with the substance. Gradually moisture from the hands causes a reaction and the substance becomes visible as a colored stain. Ultraviolet markers are used to write the owner's name on their possessions. If the goods are stolen and then recovered, the owner can be contacted.

TAPPING INTO CONVERSATIONS

It is often useful for law enforcement officials to gain access to an individual's telephone conversations. One method of tapping is to connect wires and a transmitter to the junction box outside the building. Another method is to fit a radio transmitter directly into the telephone handset, sending conversations to a receiver set.

Crime scene

THE LOCATION OF A criminal incident is called the scene of the crime. The first job of police officers at the crime scene is to seal off the area so that potential evidence is not disturbed. Once this has been done, only authorized persons are allowed within the area. The most important members of the investigation team at this point are the scene-of-crime officers (SOCOs), who use their extensive training and experience to search for clues to be sent to the forensic laboratory for examination (pp. 46–47). Forensic science is the technique of using scientific methods to solve crimes. Modern forensic science had its origin in 1910, when Edmond Locard of France formulated his “exchange principle.” This theory simply states that a criminal always takes something away from the scene of the crime – or leaves something behind. The criminal may take away hair or blood from the victim, or soil (peculiar to the area) on the soles of his or her shoes. The criminal may leave fingerprints, footprints, or fibers from clothing. It is this evidence that the SOCOS collect.



MURDER!
In the case of murder, the body of the victim must be removed from the crime scene and taken for a postmortem as soon as possible. Before this can happen, the victim must be pronounced dead by a doctor. Then a forensic pathologist makes a preliminary examination. Next, a chalk or tape outline is made around the corpse so that investigators know its position. The body can then be transported to the hospital mortuary, where the autopsy takes place.



HUNTING FOR CLUES
This picture shows the hunt for information at the scene of a murder in New York. Nothing in the room has been touched or moved to allow scene-of-crime experts and photographers to record as many details of the crime as possible. A police photographer is recording relevant evidence on film, while his colleague searches for evidence that may be sent to the forensic laboratory.

THE AMPEL PROBE
This tool was designed for use by crime scene investigators. The tongs enable officers to search suspects or their property without risking personal injury (for example, from an open knife) and without damaging objects that may bear trace evidence such as fingerprints. It also is useful for removing evidence without personal contact.

SCENE-OF-CRIME KIT
 As most crime scene investigations must be carried out at a moment's notice, valuable time is saved if a SOCO has a ready-packed case of equipment. This case contains fingerprinting kits (pp. 44–45) and collecting bags and tubes to preserve clues. A coverall, cap, gloves, and shoe covers are provided so that a SOCO will not introduce foreign materials to the scene.

AT THE SCENE OF THE CRIME
 This officer, dressed in a plastic coverall, protective gloves, and shoe covers, is searching for evidence among blades of grass. He is using tools from a scene-of-crime kit to collect evidence. The collection of evidence can be a laborious task at an outdoor crime scene, as there may be a very large area of ground that must be searched for possible clues. The clues may also have been moved or damaged by animals or the weather.



Following clues

DROPS OF BLOOD

Marks left by blood can reveal much to the specially trained crime scene investigator. The shape of blood drops on a flat surface can indicate from what height they fell. Splashes on a wall can show the direction from which they came. Other patterns are spurts, pools, smears, and trails. These may reveal the movements of the victim and criminal, and help investigators piece together the crime.

SEEMINGLY INSIGNIFICANT traces left at the scene of a crime by the victim or criminal are vital clues that can help police in their investigations. Fingerprints, tire prints, and shoe prints can help identify a criminal; bloodstains can illustrate where or how the crime took place. Investigating officers carefully analyze every aspect of a crime scene, even clues that might not be noticed by an untrained person. More dramatic clues, such as bullet holes and broken glass, are easily noticed, but special training and equipment are needed to analyze this kind of evidence. The damage caused by weapons can also provide clues. For example, a piece of glass shattered by a bullet may leave traces on a criminal's clothes.

BULLET MARKS

Cartridges consist of two parts: bullets and cases. When a gun is fired, the bullet travels along the barrel and picks up marks unique to that gun, which can be compared with a test bullet fired from the same weapon. Marks left on the base of the case by the firing pin can be compared in the same way. By comparing bullet marks, investigators can connect a particular weapon to a particular crime.

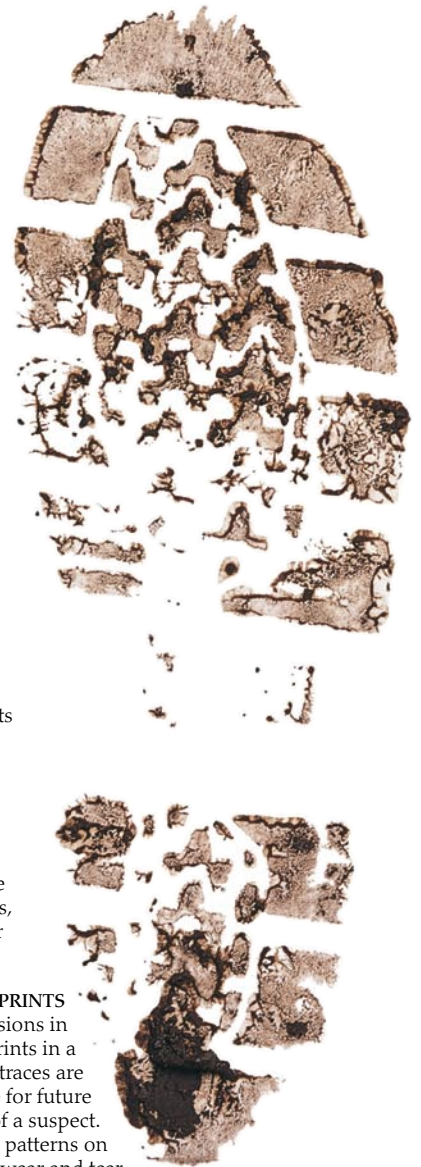
SHOE PRINTS

Shoe prints are left either as impressions in a substance such as soil, or as prints in a liquid such as blood or oil. These traces are photographed at the scene for future comparison with the shoes of a suspect. Identification points may be the patterns on the sole and distinctive signs of wear and tear.

TIRE PRINTS

Prints left by tires can be compared with the tires on a suspect's car. Like shoes, tires often have an identifiable wear pattern. Police are further helped by the fact that manufacturers use different types of tires on different models of car.

SHOTS THROUGH GLASS

Ballistics is the study of guns and ammunition. In a forensic laboratory specializing in ballistics, experts set up tests to demonstrate the effects caused by bullets fired from different distances and through different thicknesses of glass (above). Police can refer to this information when they examine a bullet hole in glass from a crime scene. It can indicate the spot from which the gun was fired.



BREAKING GLASS
When glass is smashed, the broken edges have tiny shell-shaped notches. A broken window can be fitted together like a jigsaw puzzle. A piece of glass discovered in a suspect's car can be compared to glass recovered from the crime scene. If the notches fit exactly, the glass is from the same windowpane.



REFRACTIVE INDEX
Tiny pieces of glass found on a suspect's clothing may be too small to fit into a glass jigsaw. Instead, the recovered glass can be compared to glass from the crime scene by measuring its refractive index, or the amount a ray of light bends when it passes through glass. Different kinds of glass have different refractive indexes.

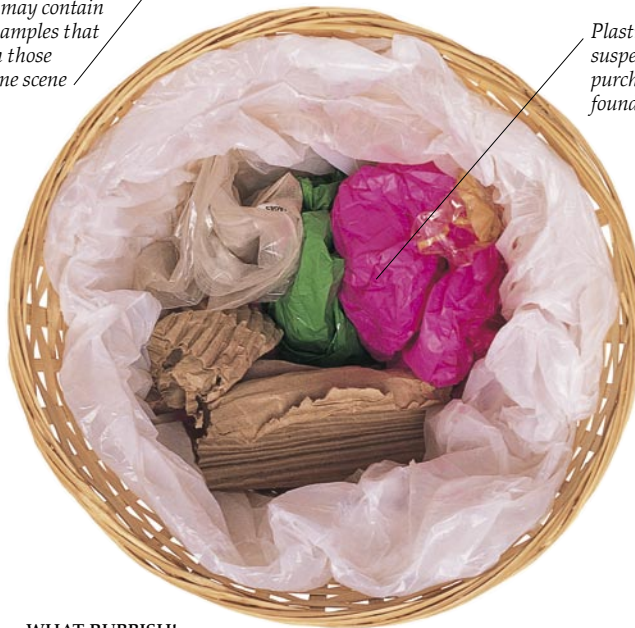

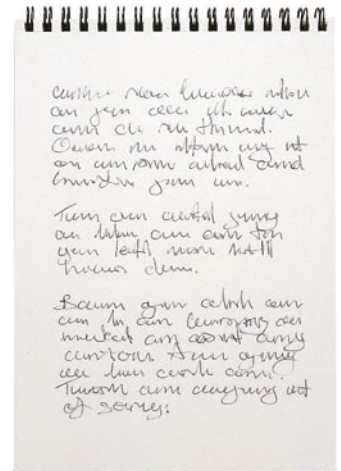

DUST AND SOIL ANALYSIS
Because dust and soil are so easily carried from the crime scene – on skin, shoes, and clothing, or in the hair of a suspect – they are useful for comparison with similar substances at the scene. Both dust and soil vary greatly in their contents, often over a small area, so this analysis can prove quite accurate.

LOOKING AT DOCUMENTS
No two people's handwriting is the same. A handwriting expert can compare a scribbled note to a handwriting sample from a suspect. A seemingly blank page may contain indents from writing on the previous page, which has been torn off. This, too, can be used to identify a suspect.

WHAT RUBBISH!
Garbage is routinely searched for evidence after a crime. For example, discarded documents, such as letters, may reveal a suspect's movements in the weeks leading up to the crime. Search of a garbage pail may result in the recovery of actual evidence, such as a weapon or stained clothing.

IN THE LABORATORY
Forensic laboratories usually specialize in one particular branch of science, such as biology, chemistry, or ballistics. Some of the equipment is specific to that subject, but most laboratories rely heavily on comparison microscopes (pp. 46–47). This busy laboratory (left), like most other labs, has evidence from hundreds of crimes awaiting analysis.

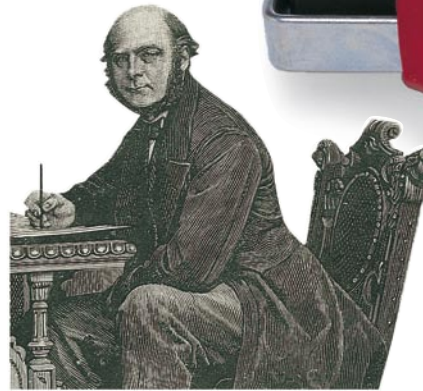

IDENTIFYING TOOL MARKS
Marks are sometimes left by an implement, or tool, used to force open a door or window at a crime scene. Because the tool is harder than the wooden frame, it leaves an impressed imprint of its shape. Sometimes this can be matched to a tool owned by a suspect – particularly if it has a distinctive shape or marks of previous damage.

Fingerprints and DNA

MANY EARLY CIVILIZATIONS were aware of the unique nature of the ridges and furrows on the tips of the fingers. Chinese potters, for example, signed their work with a fingerprint. However, it was not until 1858 that William Herschel, an English civil servant in India, claimed that no two person's fingerprints are the same, and that they do not change with age. During the late 19th century, researchers developed a method of classifying prints so that they could be easily identified. Just as fingerprints are unique to an individual's fingertips, so deoxyribonucleic acid (DNA) is unique to every cell of an individual's body. In 1984, scientists began to create DNA profiles, sometimes called genetic fingerprints, from body fluids, flesh, skin, or hair roots. By matching the genetic information from a forensic sample with that of a suspect, investigators can prove a suspect guilty or innocent.

Sir Francis Galton (1822–1911) was an English scientist who made the first advances in identifying the basic patterns of fingerprints. Sophisticated modern methods are based on the classification system he devised during the 19th century.

INK AND ROLL
The universal method of taking a suspect's fingerprints is called ink and roll. A thin coating of black ink is rolled onto a metal plate. Then, one by one, each of the subject's fingertips is rolled on the ink from one side of the nail to the other, then rolled onto a white chart, producing prints.

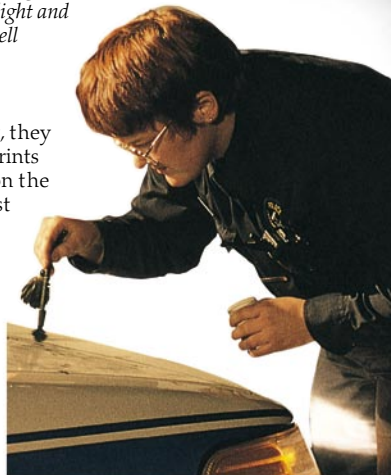

BRUSHING UP

If fingerprints have been left in a substance such as blood or paint, they are easy to see. However, most prints are made by the oils and sweat on the surface of the skin and are almost invisible. The most common technique for revealing these fingerprints is to dust a fine powder over the surface, which sticks to the oily deposit. The powder-covered prints are removed from the surface on transparent sticky tape and then photographed. This officer is dusting for prints on a stolen car.

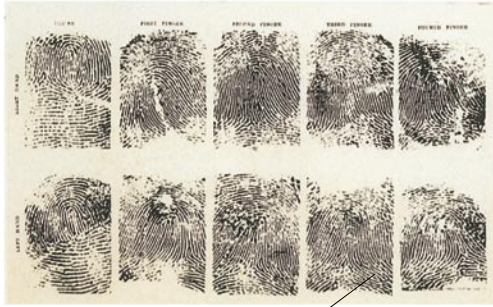

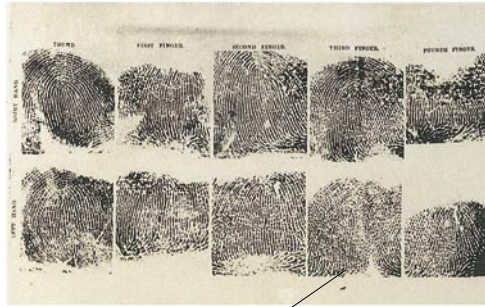

CATALOGING PRINTS

Fingerprint records are kept so that a suspect's prints, or fingerprints found at a crime scene, can be checked against any existing records. Checking is performed by specialists who look for points of similarity between the prints. In Britain, for example, sixteen points of similarity must be found to confirm a match. This amount varies from country to country. As the number of fingerprint records has grown, a computer system has been developed that is able to store the records and compare more than 60,000 fingerprints per second.

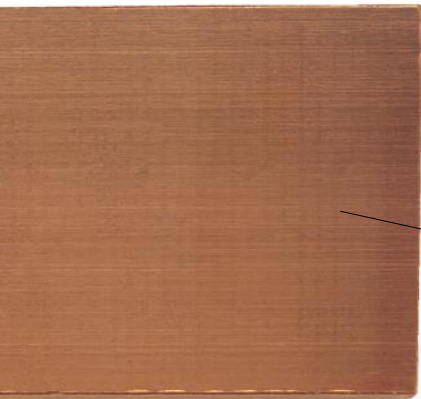

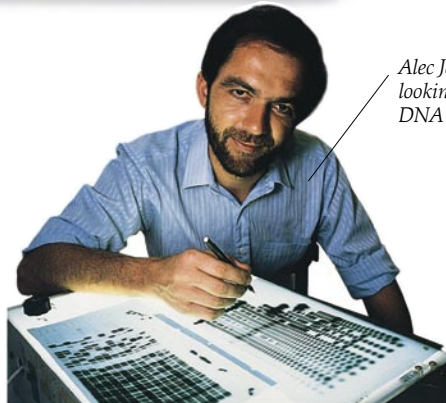

FINGERPRINT PATTERNS

In the late 19th century, Sir Edward Henry of Scotland Yard developed a system of classifying fingerprints. According to his method, known as the Henry system, all fingerprints can be organized into four main types. "Arches" have ridges that run from one side of the finger to the other. With "loops," the ridges make a backward turn, and "whorls" have ridges that make a circle. Some prints include all three patterns and are called "composites."

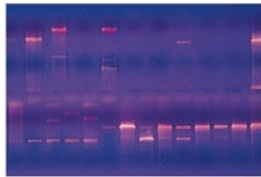


Metal plate for taking fingerprints. Once the plate is covered with ink, the finger is rolled across it

EVIDENCE IN A MOLECULE
In 1984, English geneticist Alec Jeffreys made DNA the international standard for identification. He discovered that within a single DNA molecule there is a sequence of information unique to each individual (except identical twins, who have the same DNA). Like fingerprinting, DNA profiling can be used to connect a suspect with the scene of a crime.



BIOLOGICAL "PATTERN"
From a sample of any human tissue or body fluid, a biological "pattern" of that person can be created. This is called a DNA sample and looks like a supermarket bar code.

MAGNETIC PRINT

Many substances are used as dusting powders. The type used depends on the surface on which the print has been left. For example, some powders are more suitable for sticky surfaces, while others are better for paper and cardboard.

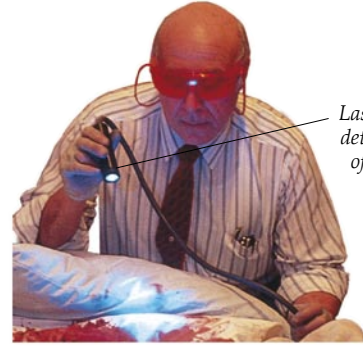
NAPOLEON'S DEATH

Napoleon Bonaparte's death in 1821 was ascribed to stomach cancer. However, there have been persistent rumors that he was poisoned. In 1960, a forensic team analyzed a lock of Napoleon's hair taken from his head when he died. More than 13 times the normal level of arsenic was found. The poison could have been administered deliberately, or ingested by accident.

DESPITE DEVELOPMENTS IN technology, the basic principles of forensic science have remained the same. A forensic scientist's main task is comparison.

For example, the scientist will compare a hair found at a crime scene with one from a suspect's head, or match a fabric fiber found in a suspect's car with the clothing worn by a victim. The main techniques used are microscopic examination and chemical analysis. A forensic laboratory will use several types of microscopes in their work; electron microscopes can magnify objects more than 150,000 times, which makes identification and comparison easier. Comparison microscopes are used,

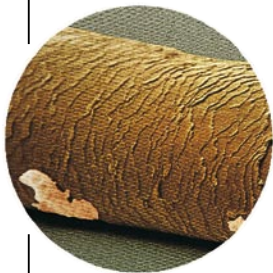
allowing a scientist to view two samples side by side through the eyepieces. Other types of microscope can help compare bullets to determine their source, or identify minerals and drugs. Forensic laboratory work combines many different disciplines, such as biology, chemistry, ballistics (the study of guns and ammunition), and document analysis.



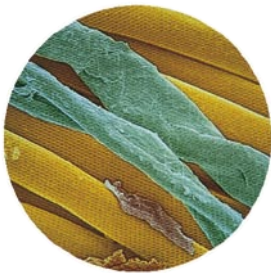
Laser lamp used to detect the presence of proteins, found in body fluids

SEARCHING FOR SALIVA

Forensic scientists often look for evidence left at murder scenes. The pillow (above) has been sprayed with a substance that binds with protein. The protein will fluoresce under the laser lamp, showing the presence of body fluids, such as saliva. The pillow can then be sent to the laboratory for DNA analysis (pp. 44–45).

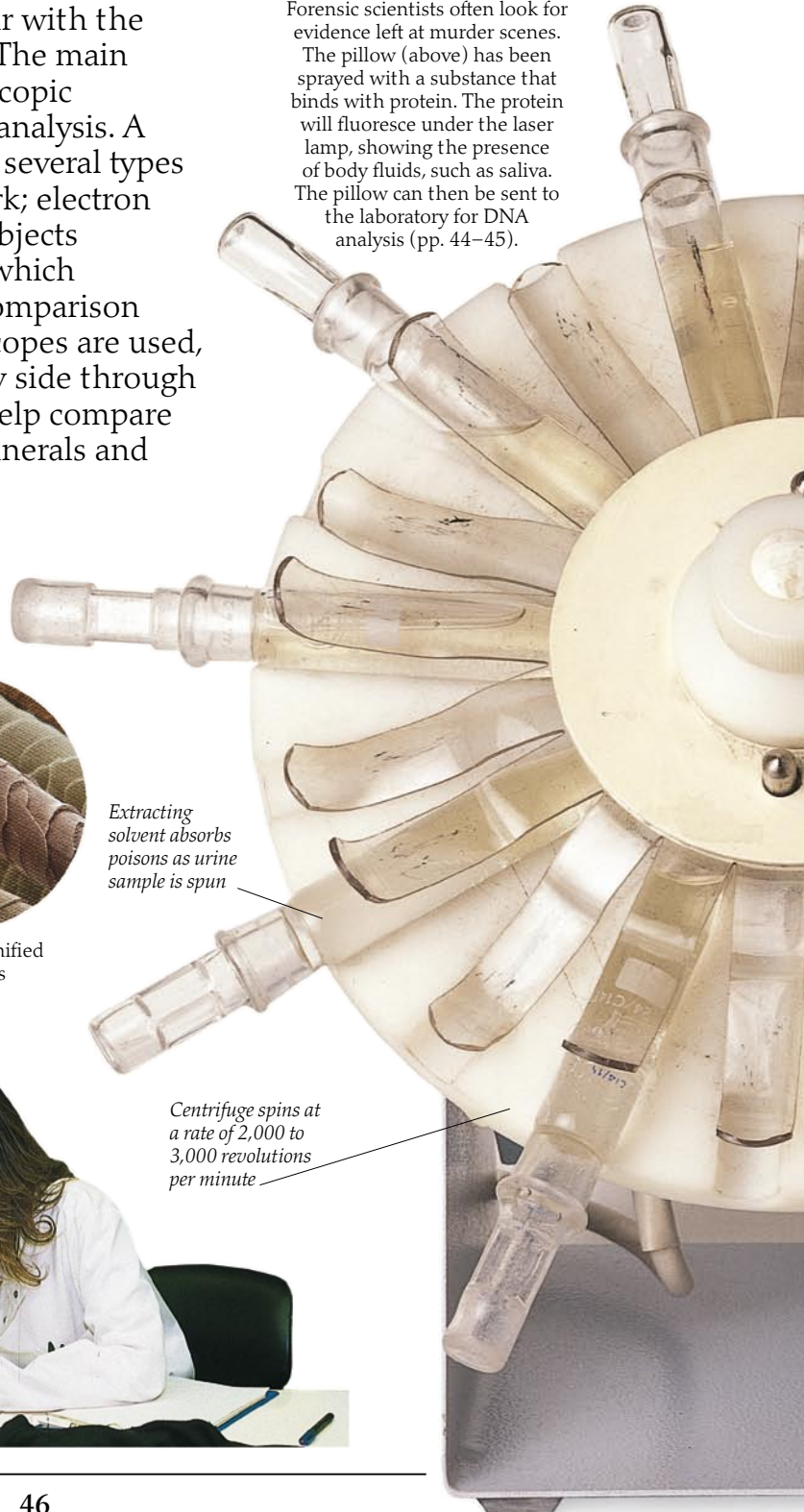

IN THE LABORATORY

The forensic laboratory is one of the most valuable tools in a crime investigation. Clothing, shoe prints (pp. 40–41), dust traces, weapons, and bullets are a few items that may be analyzed in the crime laboratory. This scientist is using a comparison microscope. Originally designed for the comparison of bullets and cartridge cases, it is now used to compare almost any kind of evidence. Two slides carrying samples are placed on the viewing tray. The slides are viewed simultaneously through the eyepieces.

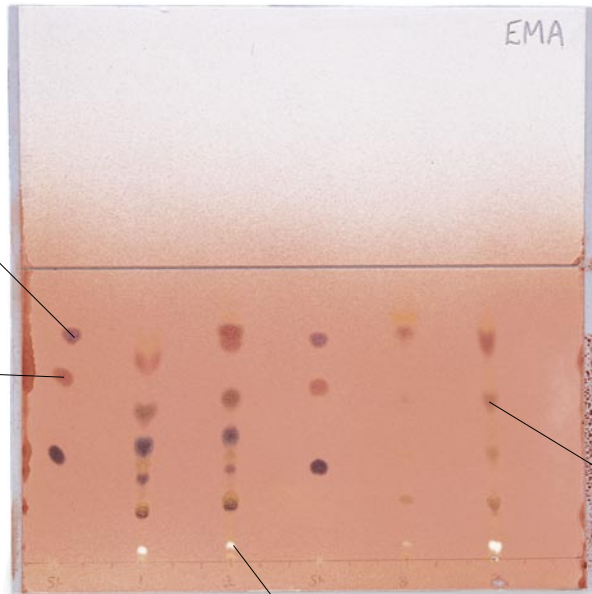


Extracting solvent absorbs poisons as urine sample is spun

Chromatogram of five sample extracts

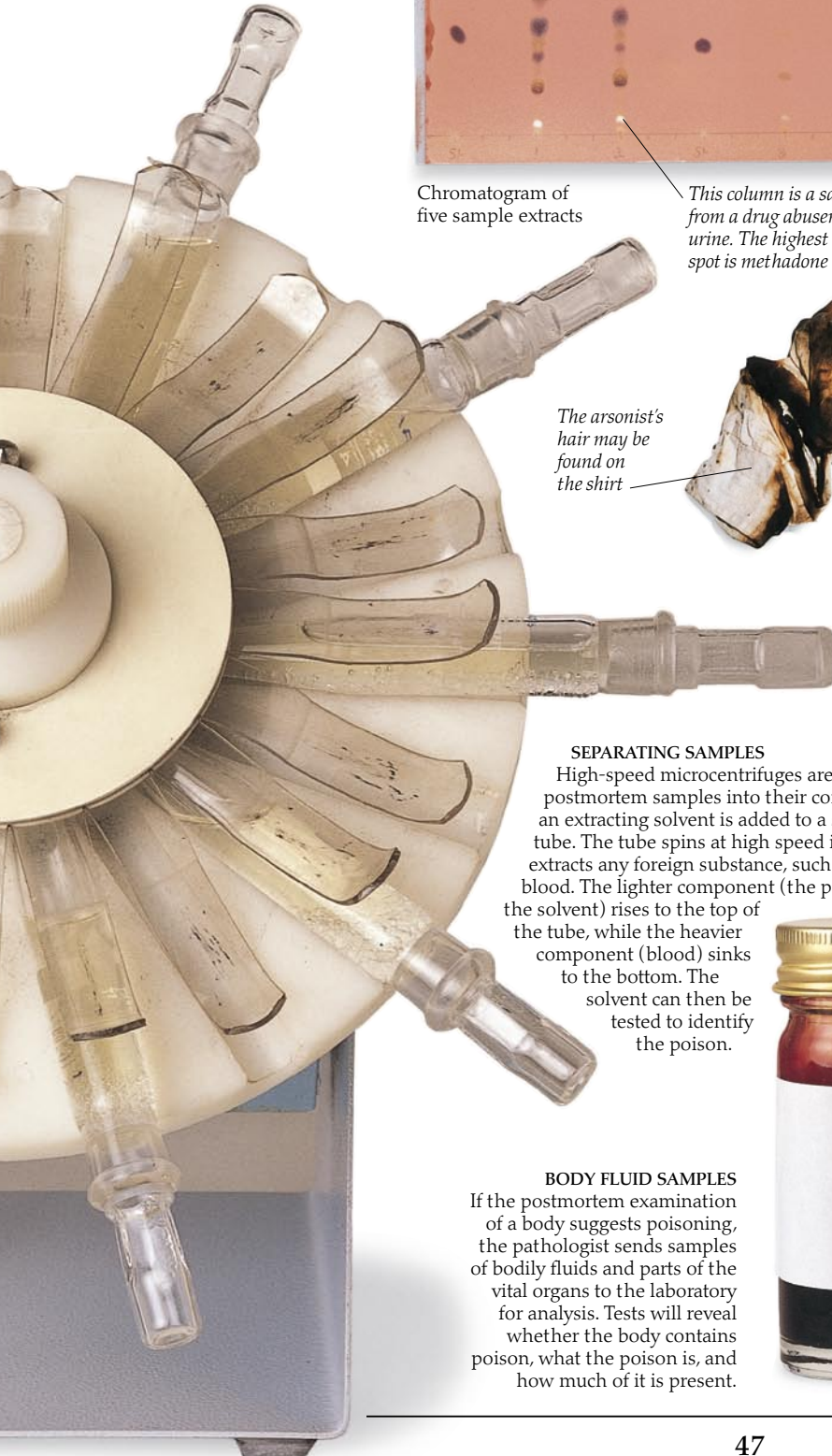

IDENTIFYING POISONS

Thin-layer chromatography is a technique used to identify the various components in poison and drug samples extracted from body fluids. A glass slide is coated with silica gel, and spots of the sample are applied just above the bottom edge. The slide is lowered into a tank containing a liquid that reaches just below the line of sample spots. As the liquid rises up the gel (just as water rises through blotting paper), it carries with it the different components of the sample. As different substances rise at different rates, each sample is separated into a series of dots rising up the slide. Each dot is a different component of the sample. The slide can be compared with previous results and the components identified.

SHIRT SLEEVE

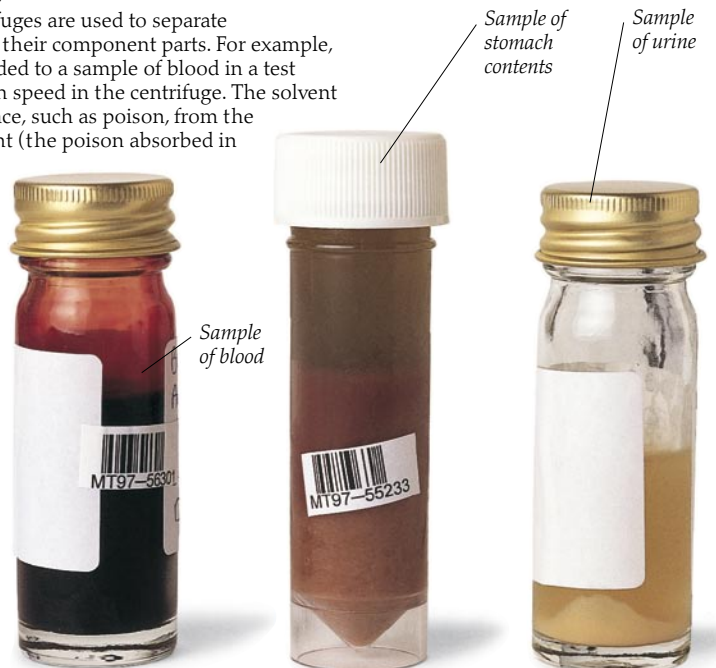
This burned shirt sleeve, taken from the victim of a suspicious fire, will be sent to the laboratory. The autopsy had already proved the victim died before the fire started – there was no soot in the lungs, so he had not breathed smoke. Scientists will test the fabric to determine if it had an accelerant, such as gasoline, on it. Such a finding would strengthen the theory that the fire was started deliberately in an attempt to hide a murder.

SEPARATING SAMPLES

High-speed microcentrifuges are used to separate postmortem samples into their component parts. For example, an extracting solvent is added to a sample of blood in a test tube. The tube spins at high speed in the centrifuge. The solvent extracts any foreign substance, such as poison, from the blood. The lighter component (the poison absorbed in the solvent) rises to the top of the tube, while the heavier component (blood) sinks to the bottom. The solvent can then be tested to identify the poison.

BODY FLUID SAMPLES

If the postmortem examination of a body suggests poisoning, the pathologist sends samples of bodily fluids and parts of the vital organs to the laboratory for analysis. Tests will reveal whether the body contains poison, what the poison is, and how much of it is present.

The bare bones

FEW PEOPLE REALIZE HOW MUCH information an expert can glean from a pile of bones – information that can help solve a crime. Examination of a skeleton can reveal the gender of the deceased, as male and female skeletons have different skulls and pelvic (hip) bones. Even without a complete skeleton, height can be calculated within an inch (25 mm) by measuring the long bones (the femur in the leg or the tibia in the arm). Age can sometimes be determined from the way in which sections of the skull have closed together, or, up to the age of 25, from the development of the teeth. The structure of the head, face, teeth, and long bones can also indicate the indigenous group of the deceased.



MIKHAIL GERASIMOV

Mikhail Gerasimov was a pioneer of facial reconstruction in Russia during the 1950s. The reconstruction of Tamerlane the Great, the Mongol king, was Gerasimov's greatest achievement. In the illustration above, Gerasimov (left) and an archaeologist examine a 30,000-year-old skeleton.

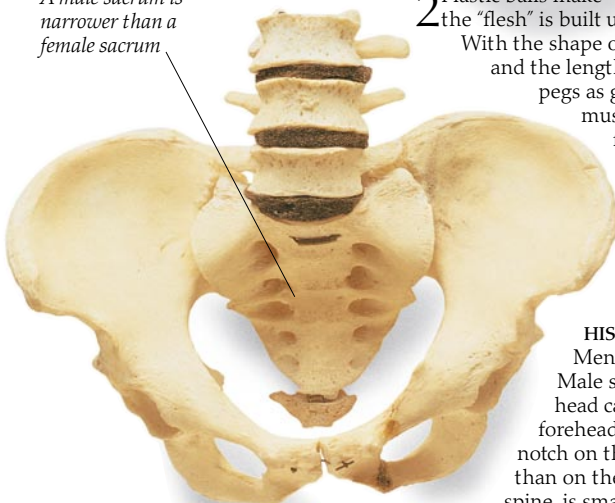
1 The skeleton of a young woman was dug up in Wales in 1989 and named "Little Miss Nobody" by the police. To begin the facial reconstruction, a cast of the skull is made. Then pegs are inserted at fixed points to indicate the standard thickness of the flesh.

2 Plastic balls make "eyes" and the "flesh" is built up in clay. With the shape of the skull and the length of the pegs as guides, the muscles of the face begin to form.

3 After the mouth, the areas around the eye sockets are carefully filled in. Then the nose is formed. Because there are few bones that indicate the shape of the nose, this is one of the most difficult parts of the reconstruction.

4 The clay has now been filled out to the tops of the guide pegs and the sculptor is ready to put the finishing touches on the head. All that remains is to smoothe the surface to give a more lifelike appearance. If the age of the person at death is known, the sculptor can texture the skin correctly. The whole process takes little more than a day to complete.

HIS AND HERS

Men and women have different skeletons. Male skulls have a little lump at the back of the head called the nuchal crest and another on the forehead called the suborbital ridge. The sciatic notch on the hips is wider on the female skeleton than on the male. The sacrum, at the bottom of the spine, is smaller in males than females.



LASER RECONSTRUCTION

The use of laser technology in the re-creation of faces was pioneered by forensic pathologist Dr. Peter Vanezis, seen here demonstrating a new system in London, England. When Karen Price was identified, Dr. Vanezis used a laser technique to superimpose a photograph on the skull made by Richard Neave. They fitted perfectly.

THE FACE MAKER

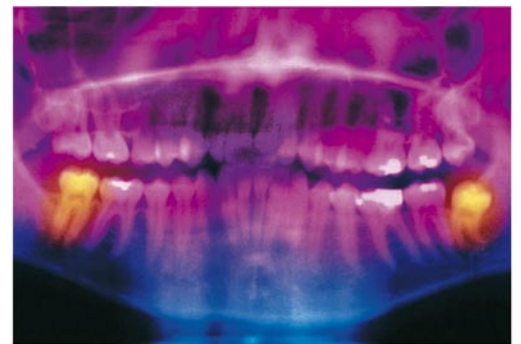

5 Photographs of the facial reconstruction were published in police notices and newspapers, and broadcast on television. As a result, a name was put to the anonymous skeleton. She was identified as Karen Price by a Cardiff social worker. Later, two men were charged with Karen's murder.



DENTAL IDENTIFICATION

Because teeth are almost indestructible, they can often be used to identify a body when other methods cannot (for example, following a fire or an air crash). A panoramic photograph, like this one, is taken of the surviving teeth and matched to the victim's dental record. As no two people have identical dental histories, this method is accurate.

Attention to detail

THERE ARE FEW “OPEN AND SHUT” cases – crimes where it is known immediately what happened, who did it, and why. Investigators usually put together a case from lots of small clues. Often no detail is too insignificant. A witness may remember the color or make of a car, or even its license plate number. An onlooker may have noticed something about a suspect – his or her voice, a physical feature, or a distinctive tattoo. Sometimes a witness recalls the criminal’s distinctive clothing or jewelry. These eyewitness details are added to the other clues picked up by scene-of-crime officers and forensic scientists and built into a case to be presented later in court.



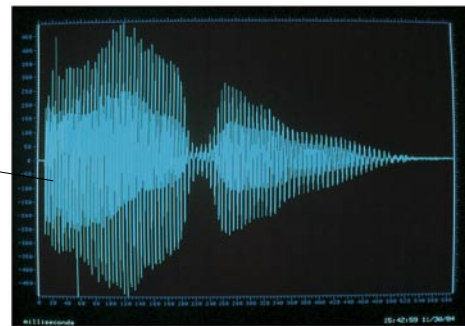
LINEUP

Lineups are used by police throughout most of the world. A suspect takes any position in a line of other people of similar appearance. The witness is then asked to identify the suspect. Lineups are not always reliable. If the real criminal is not there, a witness may choose the person who looks most like the criminal.

DISTINGUISHING MARKS

Members of gangs often like to have some way of identifying fellow members. Tattoos are a good means of identification because they cannot easily be erased. Tattoos are used by members of Chinese secret societies, such as the Triads. Individually chosen tattoos are even more useful to the police, because no two people are likely to carry the same pattern of markings.

VOICE RECOGNITION

Each human voice has a unique “print.” The current system of recording and identifying voiceprints was developed during World War II. In the bar print above, the horizontal axis records the length of time, the vertical axis measures the strength of the sound. Voiceprints can be used to identify a suspect in cases of abusive telephone calls or demands for ransom payments made by phone.

“MUG SHOT” BOOK After photography’s invention in the mid-19th century, one of its most important uses was to allow police to keep visual as well as written records of criminals. This is one of the earliest examples of a mug shot book, from the City of London Police. At that time, similar records were being kept in the United States, under the direction of Thomas Byrnes of the New York Police. In France, Alphonse Bertillon (pp. 52–53) was improving the French system by photographing criminals.

COMPUTER-AIDED VIDEO-FIT

Improved computer technology has led to the videofit, which replaces Photo-fit identification. Above, a witness is selecting the general hairstyle of the suspect. This choice is transferred to the video screen, where it can be altered to give a closer likeness. Another recent development makes the video-fit three-dimensional so that it can be seen and altered at different angles.

LICENSE PLATES
All countries have a system of matching vehicles to their owners. This information can be used by the police to check whether a vehicle has been stolen or reported at a crime scene, and to find out about the owner. Many criminals put false plates on cars to avoid detection. The British plate above is false. The numbers are too small and thick, making them difficult to read. The middle plate is a temporary French plate. The letters WW show it was issued to a person moving to a new home.

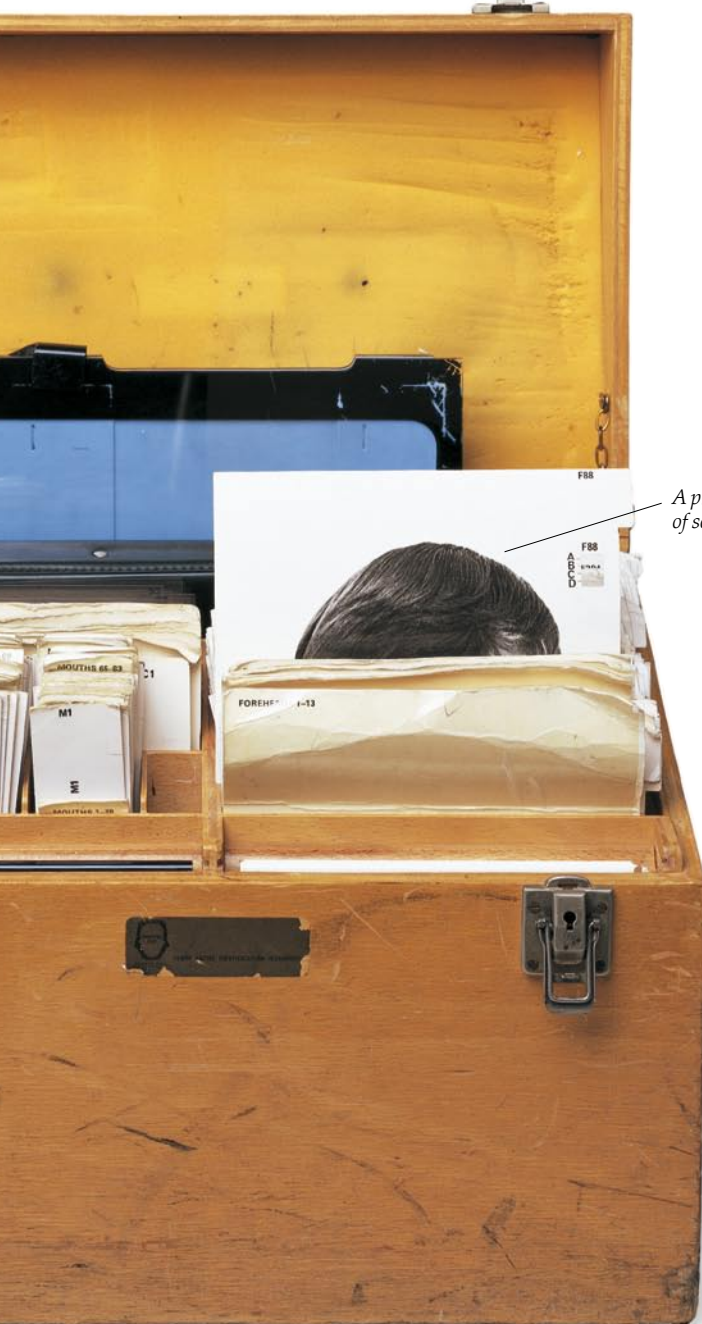

SELECTING EACH FEATURE

This selection of just two pairs of eyes, two noses, and two mouths from a Penry Photo-fit kit shows how much features can differ. The kits have about 100 different eyes, noses, and mouths. This collection represents only a small proportion of the huge variety that exists in people's features. Unlike the video-fit, Photo-fit just gives the "feeling" or "look" of a person, rather than a close representation.

PHOTO-FIT CASE

In 1971, Britain introduced the Penry Facial Identification Technique (Photo-fit). British forensic scientist Jacques Penry's kit consisted of photographic strips of different eyes, noses, mouths, jaw lines, hairlines, and ears. These features were put together by the crime witness and a police expert. The resulting Photo-fit was circulated, often leading to a conviction.

MAKING UP A FACE

To demonstrate the Photo-fit method, a "witness" was shown an ordinary member of the public (above right) and then asked to construct the portrait (above left) from memory. In a real crime situation, a traumatized witness may not remember the exact appearance of a criminal. For this reason, eyewitness identification has become devalued.

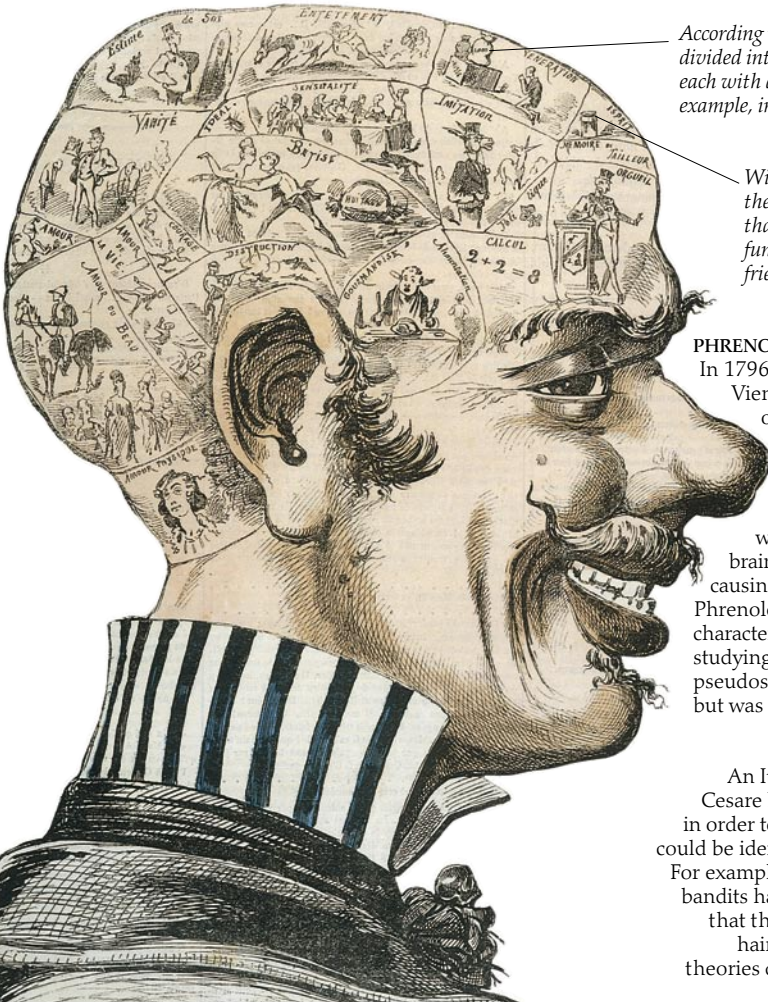
Criminal characteristics



WITCH HUNTS

In medieval times, it was thought that all witches had certain characteristics, such as warts or moles. Women thought to be witches were subjected to the ducking chair – being immersed in water while tied into a chair. If they did not drown, it was thought to prove they were witches, and they were executed anyway.

FOR HUNDREDS OF YEARS scientists have investigated the theory that certain people are born to be criminals. In the mid-19th century, anthropology, the study of humankind, became a popular science. Anthropologists studying the field of abnormal behavior examined various types of criminals to see if they shared any physical characteristics. One of the early researchers was a French prison doctor named Lauvergne, who made plaster casts of his patients' heads to demonstrate their "evil" features. Most of Lauvergne's work was found to be incorrect. However, at the same time, Alphonse Bertillon, working for the Paris police force, was also taking detailed measurements of criminals' heads and bodies, but for a different purpose. He was using the measurements to identify known criminals, rather than to create a physical profile of a criminal type.

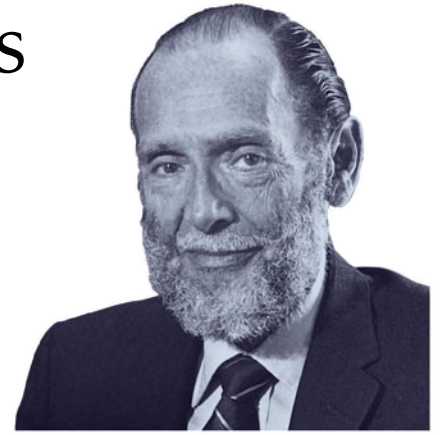
Within each brain section, there are several areas that represent different functions, such as friendship and courage

PHRENOLOGY

In 1796, Dr. Franz Gall, a doctor in Vienna, announced his theory of phrenology, in which a person's qualities and abilities are traced to particular areas of the brain. Gall believed that while people thought their brains and skulls changed shape, causing bumps on the surface. Phrenologists thought a person's character could be understood by studying the shape of the skull. This pseudoscience was initially popular, but was soon rejected as false.

CESARE LOMBROSO

An Italian psychiatrist of the mid-19th century, Cesare Lombroso made a study of 7,000 criminals in order to prove that different "criminal types" could be identified by physical characteristics. For example, he believed that swindlers and bandits had larger-than-normal heads, and that thieves and highwaymen had thick hair and beards. He never proved his theories despite the elaborate instruments he invented in order to do so.

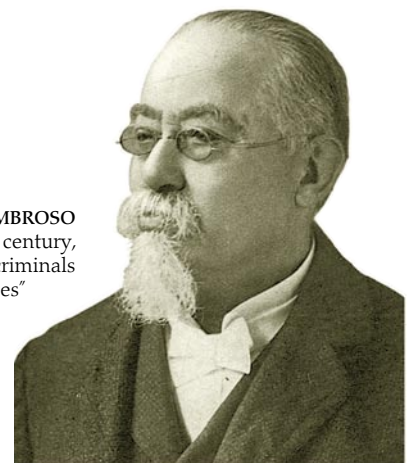


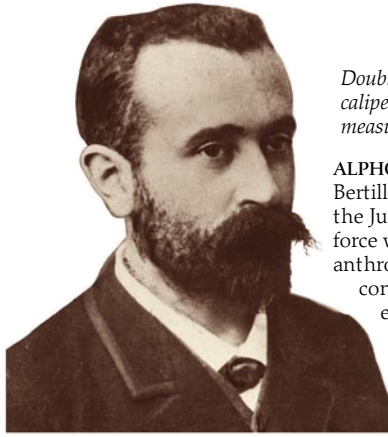
"SHERLOCK HOLMES OF THE COUCH"
Dr. James Brussel, an American criminal psychiatrist, has been called "the Sherlock Holmes of the couch." Brussel was a pioneer in psychiatric profiling – a method of deducing a criminal's characteristics by studying the way a crime is carried out. Dr. Brussel used his theory successfully to help solve many crimes. He helped capture New York's "Mad Bomber" in 1957 (below) and helped catch Albert DeSalvo, the "Boston Strangler," in 1963.



THE MAD BOMBER

In 1940, George Metesky began a 16-year series of bombings to seek revenge on his previous employer, who he believed had wronged him. The accurate description of Metesky given by Dr. James Brussel led to Metesky's arrest (above). Metesky was found unfit to stand trial and was committed to a state hospital for the criminally insane.

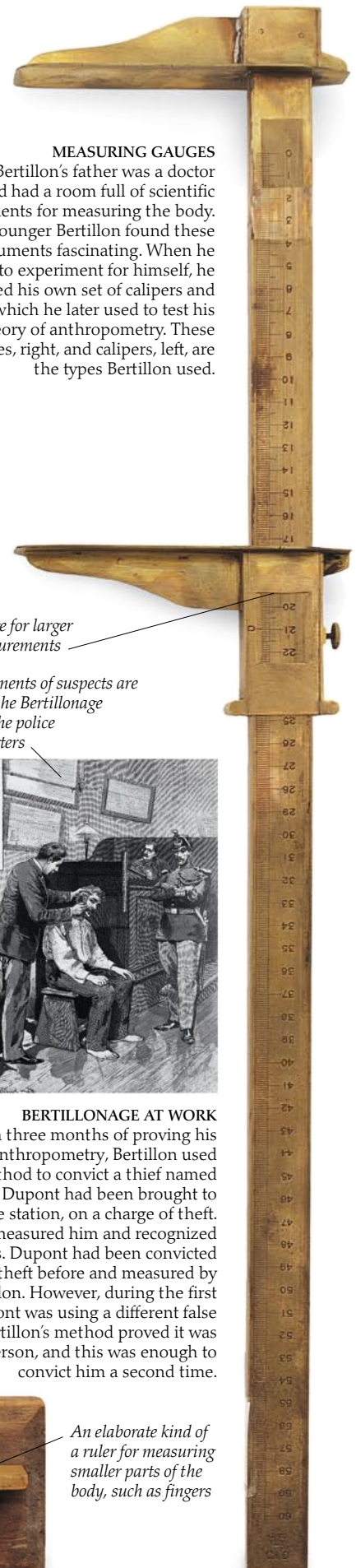




Double-headed calipers for smaller measurements

ALPHONSE BERTILLON

Bertillon was an assistant clerk in the records office of the Judicial Identification Service in the Paris police force when, in 1883, he proposed his theory of anthropometry ("man measurement"). Bertillon concluded that no two human beings have exactly the same measurements, and he devised a method of identifying criminals by comparing records of individual physical attributes. Bertillonage was adopted as a general system in France. However, it was soon replaced by fingerprinting (pp. 44–45).



MEASURING GAUGES

Bertillon's father was a doctor and had a room full of scientific instruments for measuring the body. The younger Bertillon found these instruments fascinating. When he began to experiment for himself, he collected his own set of calipers and gauges, which he later used to test his theory of anthropometry. These gauges, right, and calipers, left, are the types Bertillon used.



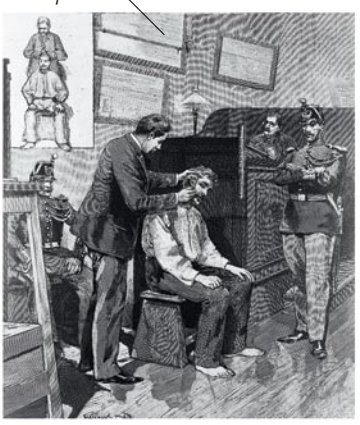
Original Bertillon "mug shot" book

BOOK OF FEATURES

Another of Alphonse Bertillon's successes was recognizing the value of the newly invented science of photography. Prior to this, the visual appearance of criminals was recorded in words, called a *portrait parlé*, or spoken picture. It became possible to assemble classified books of photographic portraits. Looking at these, witnesses could identify criminals. These are the predecessors of mug-shot books, commonly used today.

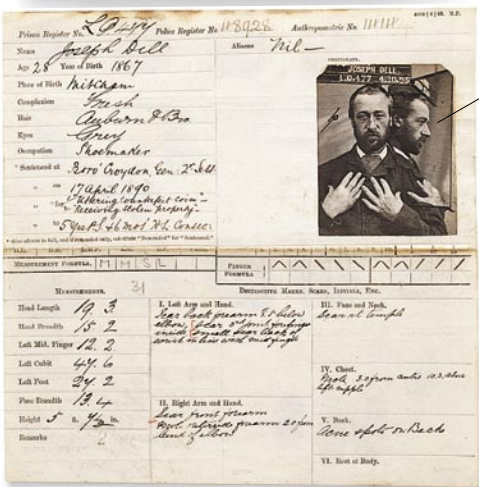

BERTILLONAGE AT WORK

Within three months of proving his theory of anthropometry, Bertillon used his method to convict a thief named Dupont. Dupont had been brought to the police station, on a charge of theft. Bertillon measured him and recognized the results. Dupont had been convicted of theft before and measured by Bertillon. However, during the first arrest, Dupont was using a different false name. Bertillon's method proved it was the same person, and this was enough to convict him a second time.

CRIMINAL RECORD

Bertillon's clerks kept detailed files that included names, addresses, and crimes committed. Also recorded were various measurements of parts of the body. Eventually, photographs of the criminal, including both front and side views, were attached. This method of presenting full-face and profile shots is now used throughout the world.

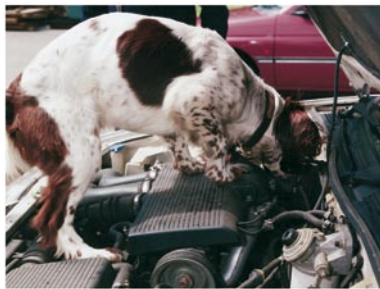

BLOODHOUNDS

Traditionally, tracking human beings has been the bloodhound's special skill. Commissioner Sir Charles Warren introduced bloodhounds to London's Metropolitan Police in the 1880s. To test the bloodhounds' ability, Sir Charles acted as quarry to see if the dogs could track him down. They did – and one of them bit him! However, bloodhounds have now been replaced by lighter, more agile breeds.

DOGS HAVE A SUPERIOR SENSE OF SMELL to humans, and their keen noses have made them useful colleagues in the police fight against crime. By following an individual's unique and invisible scent, dogs are able to track down his or her whereabouts. Police forces train dogs to chase, grab, and hold a suspect, and then release the suspect on command. Dogs have been used to track criminals for a long time. References to police dogs can be found in the 19th-century writings of Charles Dickens and Sir Arthur Conan Doyle, and in the 19th-century United States, dogs were often used to hunt escaped convicts and runaway slaves. During the 20th century, the role of the canine detective has grown. Police and other law enforcement agencies now train dogs to sniff out drugs and explosives.



CHECKING A CAR

Many vehicles travel around the world on ships and ferries. At ports, specially trained sniffer dogs inspect vehicles for illegal substances such as drugs. Here, a dog is checking the engine compartment of a car.



SUSPICIOUS SUITCASE

Airports also face smuggling problems. Dogs are used to search baggage holds. They are trained to recognize and detect the scents of contraband items such as drugs or bomb-making equipment. The dog alerts its handler if it picks up a suspicious scent.

SPECIAL TRAINING

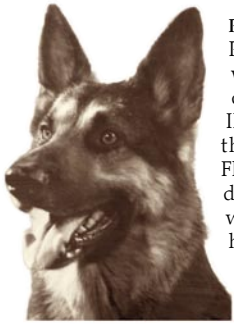
Only puppies with good temperaments are selected for the rigorous training that a police dog must complete. A 14-week-old puppy is given to a handler, who takes it home to become part of his or her family. When the dog is one year old, it receives 14 weeks of basic training, during which it is taught to obey voice and hand signals and to track and hold a fugitive. The training also involves fitness exercises to build the dog's stamina and agility.



SUPER SENSE

All around the world customs and excise authorities (pp. 28–29) use dogs to sniff out illicit chemicals. Springer and cocker spaniels and Labrador retrievers are commonly used to hunt out substances such as cocaine and marijuana. However, sniffer dogs hunt not only for drugs. The U.S. Department of Agriculture has its own "Beagle Brigade" to search for illicit fruit and meat in airports.

REX III
Perhaps the best-known of all police dogs was Rex III, whose exploits in England during the 1950s are almost legendary, Rex III made more than 130 "arrests" and was the first dog to work with the famous Flying Squad and to be trained to detect drugs. During his active service, Rex III was awarded many honors and medals.

FINDING A VICTIM
During the blitz of London in World War II, sniffer dogs were used to locate people buried beneath the debris of bombed buildings. Dogs are also used in murder investigations to locate the victims' bodies.

ON THE TRAIL OF A SUSPECT
Like police horses (pp. 34–35), dogs are trained to ignore loud noises such as gunfire. During their training, police dogs are taught the best way to attack and to avoid being clubbed by a weapon. Sadly, many brave animals are still killed in the line of duty.

LIGHTS, CAMERA, ACTION
Besides their superior sense of smell, sniffer dogs have another advantage over humans – they can search very small spaces. This dog is going to search a small area on the other side of a trapdoor. The animal is fitted with a special harness that contains a small video camera, lights, and a battery pack. This allows the handler to see the interior area.

ARRESTED BY A DOG
Police dogs are taught to attack a suspect only on the command of their handler. During their training, police dogs learn how to restrain a suspect by the arm. An instructor, wearing heavily padded sleeves to prevent injury, plays the part of the fleeing suspect. Despite their efficiency when attacking, police dogs have gentle natures.

Outlaws

IT IS A STRANGE FACT that some of the worst criminals in history have become popular folk heroes. One of the best examples is Dick Turpin (p. 14), a murderous thug who terrorized travelers in the countryside around London during the 18th century. He became a romantic figure after the publication of *Rookwood* (1834), a novel written by Henry Ainsworth in which Turpin

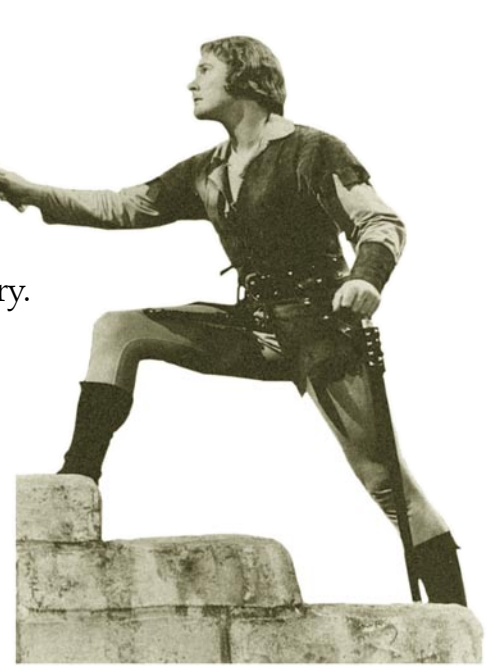
was portrayed as a chivalrous highwayman riding his trusty horse, Black Bess.

Books are not the only inspiration for hero worship. Some people long for the freedom of an outlaw, and admire his or her daring. More recent antiheroes range from the Great Train Robbers (p. 17) to India's Bandit Queen (below).



LOUIS MANDRIN

Louis Mandrin was one of the best-loved smugglers France has ever known. In the 1740s, he formed a gang of 2,000 men, who were so well trained that they often defeated the king's troops. Mandrin's dashing adventures made him the people's hero. He was captured in 1755 and was executed by being tied to a large wheel. His limbs were crushed as the wheel turned, and he was left to die.

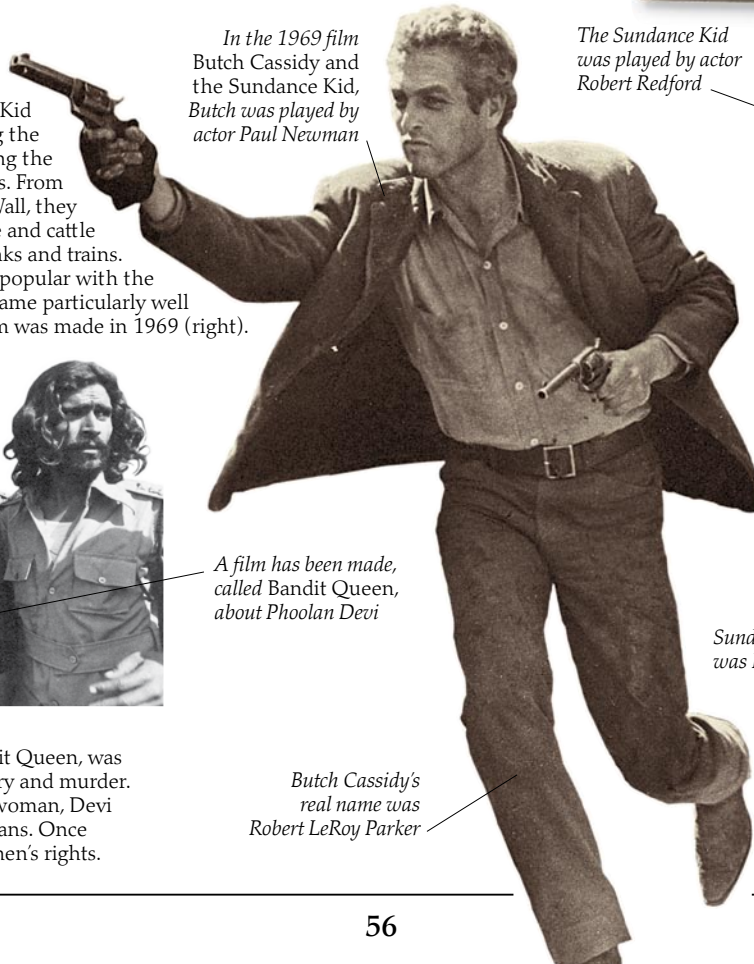


ROBIN HOOD

England's most legendary outlaw, Robin Hood, robbed the rich and gave to the poor. There is no evidence that he actually existed; the stories of Robin's adventures are based on medieval ballads that have been embellished through the centuries. He has remained popular and has become the subject of numerous films, such as *The Adventures of Robin Hood* (above), 1938, starring Errol Flynn as the notorious outlaw.

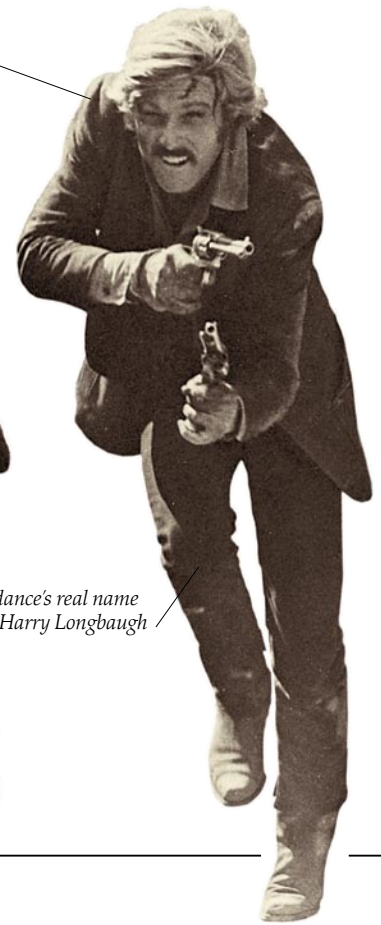
BUTCH AND SUNDANCE

Butch Cassidy and the Sundance Kid were members of the outlaw gang the Wild Bunch, who operated during the 1890s in the western United States. From their hideout, the Hole in the Wall, they specialized in large-scale horse and cattle rustling and armed robberies of banks and trains. These outlaw gangs were always popular with the public, but Butch and Sundance became particularly well known after a romanticized film was made in 1969 (right).

BEFORE THEY MET

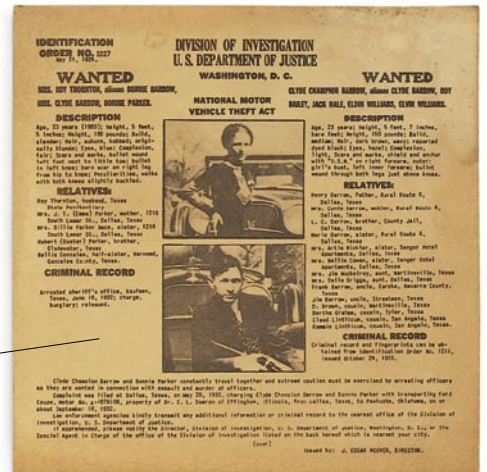

BONNIE AND CLYDE
In 1932, Clyde Barrow and Bonnie Parker teamed up to become the most infamous pair of robbers and murderers of the decade. They terrorized the southwestern United States, murdering at least 13 people. In 1934, Bonnie and Clyde were ambushed by police officers, who killed them by firing 150 gunshots into their car.

GANG MEMBERS

Clyde's brother Buck and sister-in-law Blanche were also members of the gang along with robber Floyd Hamilton. Buck was shot dead in 1933, while Blanche was captured and imprisoned. In 1938, Hamilton was sentenced to 20 years in Alcatraz (pp. 12-13).

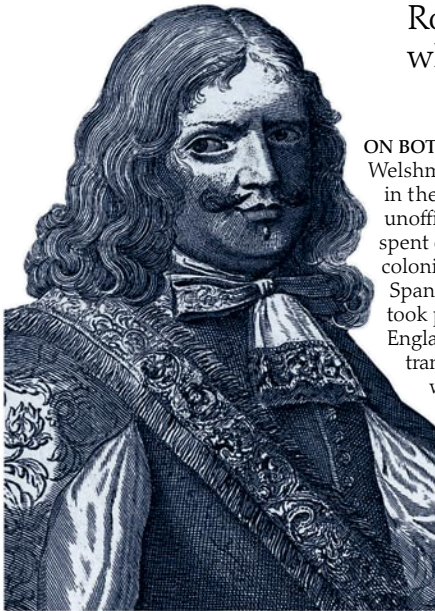
Strange but true



LINDOW WOMAN

In 1983, a badly decomposed female head was dug up at Lindow Moss in Cheshire, England. Frightened by the discovery, a local man confessed to the police that he had killed his wife 23 years before and buried her in the peat bog. In fact, when the remains were scientifically dated, they were found to be more than 1,770 years old.

CRIME AND THE LAW are serious subjects. However, crime also has its share of lighter moments and strange stories. Sometimes criminals are just foolish – such as armed robber José Sanchez. In 1995, when police arrived at the scene of an armed robbery in New Jersey, they found a piece of paper that the robber had used to wedge open the door of the building. It turned out to be a traffic ticket issued to Sanchez the night before the robbery, and it had his name and home address printed on it. There are other crimes that are strange because of the daring or ingenuity of the criminals, or because of the motives that inspired them. For example, in 1981 John Hinckley attempted to assassinate President Ronald Reagan in an effort to impress actress Jodie Foster, with whom Hinckley was obsessed.



ON BOTH SIDES OF THE LAW

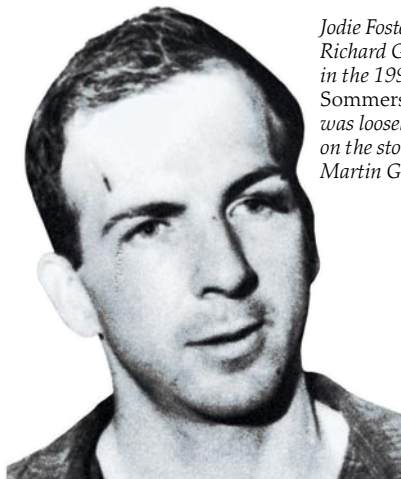
Welshman Henry Morgan was a famous buccaneer in the Caribbean of the 17th century. With the unofficial support of the English government, he spent over 10 years attacking Dutch and Spanish colonies in the area. In 1670, Morgan raided Spanish-owned Panama. Because the raid took place after a peace treaty between England and Spain, he was arrested, transported to London, and charged with piracy. Relations with Spain soured, and King Charles II pardoned and knighted Morgan, then sent him back to Jamaica as deputy governor.

Tilh was tried, found guilty, and hanged



AVENGING "NAILS" MORTON'S DEATH

Dion O'Banion (above) was one of Chicago's most notorious gangsters, and Samuel "Nails" Morton was his most loyal gunman. Morton had been awarded the Croix de Guerre during active service in World War I and was considered indestructible. However, Morton was thrown by a horse and killed while riding in Lincoln Park. In revenge, O'Banion sent gunmen to kill the horse.



MURDERING THE PRESIDENT

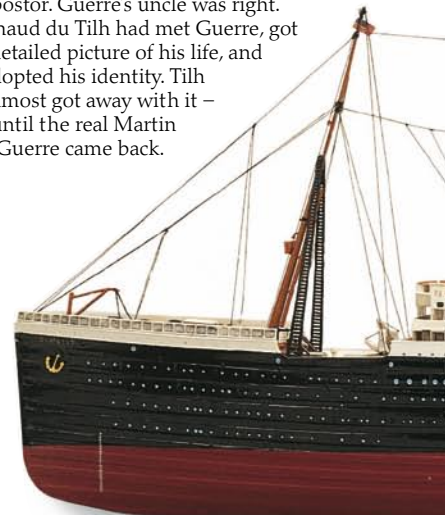
In 1963, President John F. Kennedy was assassinated in Dallas, Texas. Lee Harvey Oswald was arrested for the crime. However, because it was not a federal crime to murder the president, neither the FBI nor the Secret Service could take Oswald into custody. Instead, he was taken to a Dallas county jail, where, because of lapses in security, he was shot dead before he could be put on trial.

FAKE IDENTITY

After having disappeared for eight years, Martin Guerre returned in 1556 to his home in the French village of Artigat. He was welcomed by all except his uncle, who insisted that this Martin was an impostor. Guerre's uncle was right. Arnaud du Tilh had met Guerre, got a detailed picture of his life, and adopted his identity. Tilh almost got away with it – until the real Martin Guerre came back.

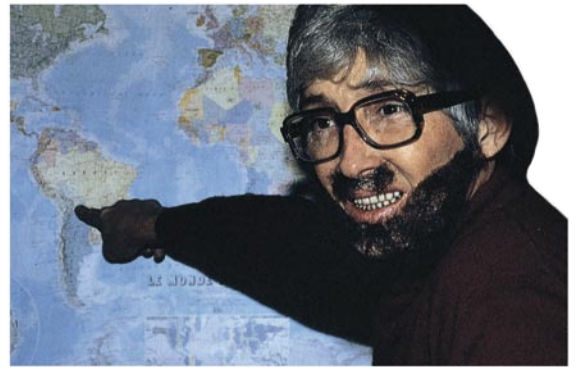




J.S.G. Boggs's drawing of an English five-pound note

FORGER OR ARTIST

In October 1986, J.S.G. Boggs, an American artist, was showing his work at London's Young Unknowns Gallery. To everyone's surprise, the police arrived and seized the pieces, which were drawings of English bank notes. The Bank of England prosecuted under the Forgery and Counterfeiting Act, but Boggs was acquitted.



ESCAPE FROM THE COURTROOM

On the night of July 17, 1976, Albert Spaggiari robbed the bank Société Générale in Nice, France, after breaking in through the underground sewer system. Spaggiari was captured and put on trial for his crime, but he made a dramatic leap from the dock and slipped out through a window. During his 12 years on the run, Spaggiari hid behind homemade disguises like the one above.



INTERNET SWEET-SHOP

A 15-year-old boy from Dublin, Ireland, used his parents' computer to order candy from a U.S. company via the Internet. When the company asked for a credit card number, the boy simply made one up. Unfortunately, it was the real account number of someone in Argentina, and \$2,000 worth of chocolate arrived at the boy's home. Since the culprit was a juvenile, he was not charged.

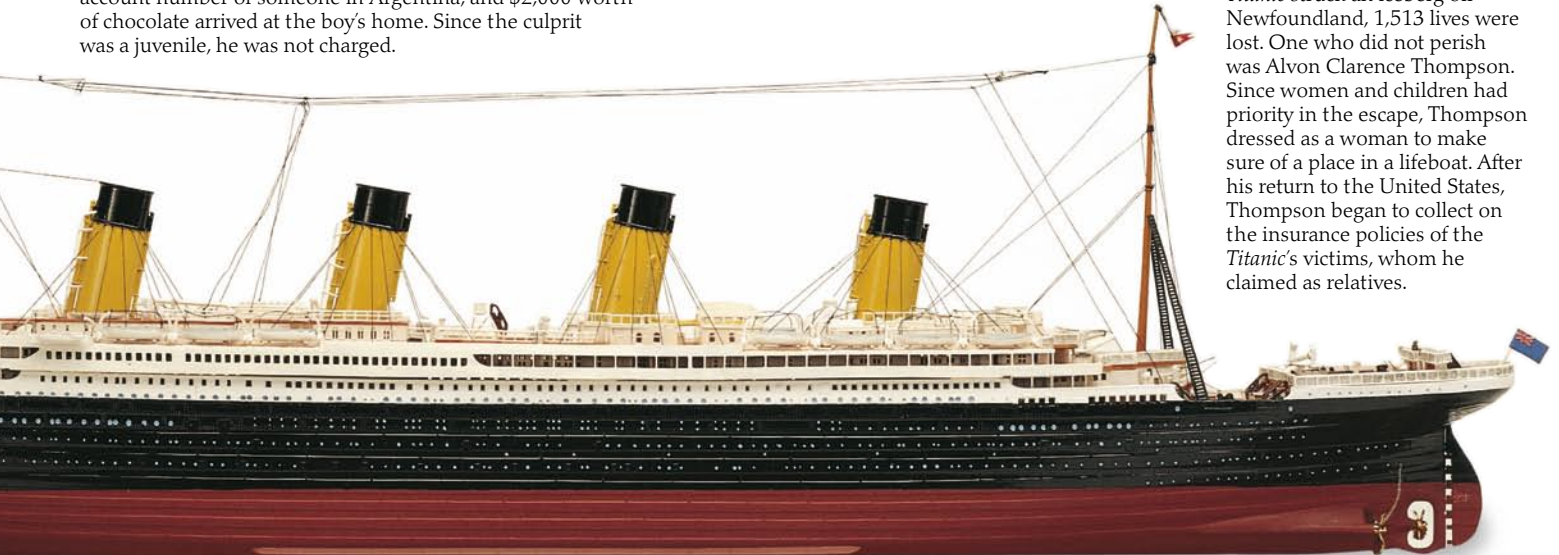


BUTTERFLY LAW

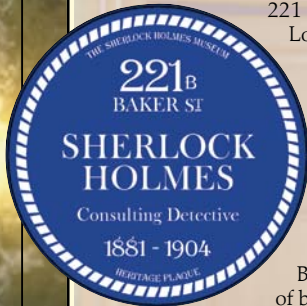
"TITANIC" THOMPSON

In April 1912, when the liner *Titanic* struck an iceberg off Newfoundland, 1,513 lives were lost. One who did not perish was Alvon Clarence Thompson. Since women and children had priority in the escape, Thompson dressed as a woman to make sure of a place in a lifeboat. After his return to the United States, Thompson began to collect on the insurance policies of the *Titanic*'s victims, whom he claimed as relatives.

AMAZING FACTS



The fictional detective Sherlock Holmes has one of the most famous addresses in all of literature: 221 B Baker Street, London. Although Baker Street exists, there was no number 221 during the years Holmes solved mysteries. Today, the building at number 221 is one of the London offices for the Abbey Building Society (a type of bank). The English Heritage Organization has posted a blue plaque on the building's facade to mark it as the former home of an important public figure. Someone is employed by the bank to answer the hundreds of letters and cards that come addressed to Sherlock Holmes every year from around the world.

Footprints do not only reveal what type of shoes a suspect was wearing. They can also give clues about the suspect's weight, height, likely age, which direction he was moving in, how fast he was going, and even if he was holding anything as he moved.

A single strand of hair can provide plenty of information to skilled investigators. They can determine whether the hair was pulled out or cut, whether the hair came from an animal or a person, and what part of the body the hair is from. It is not possible to tell whether hair came from a male or female, however, unless the root of the hair is still attached, providing DNA, which can indicate gender.

Whenever someone is in a room, they leave a trace of themselves behind, whether it is saliva on a chewed pencil top or a tiny flake of skin. Forensic investigators use special vacuum cleaners that concentrate that kind of evidence onto an evidence pad; the pad is then examined for cells.

Can a skeleton provide the key to solving a crime? A human skeleton provides many clues for a crime investigator. The bone structure (particularly the pelvic bone) can determine gender. Disease and illness can leave evidence in the bones, so an investigator can work out whether or not the person was healthy. The bones even give clues about the person's occupation (heavy labor, for example, leaves certain changes in bone structure) and where a person may have lived, by means of a chemical analysis.

The first recorded reference to forensics may have been in a Chinese book written in 1428. The book told how to tell the difference between someone who had drowned and someone who had been strangled.

A forensic entomologist (a scientist who studies insects) determines the length of time a body has been dead (or if it has been moved) by studying arthropods found on human remains. Arthropods feed on dead vertebrates and have a consistent life cycle, helping pinpoint the time of death.

Blood makes up less than 10 percent of a healthy person's body weight, but when it is spilled, a little goes a long way. It is very difficult for a criminal to clean up all traces of blood at a crime scene, as it can adhere to his clothing or the murder weapon easily. Forensic serologists (experts on blood) can derive a great deal of evidence from a tiny amount of blood.

In 1902, prison wardens routinely took fingerprint records of convicts, but the first person to be convicted of a crime on fingerprint evidence was British criminal Henry Jackson. Jackson's grubby fingerprints were found on the window of a house that had just been burglarized; Jackson, who had stolen some billiard balls, left his mark on the window as he escaped from it. His prints were matched to those on file with his former prison warden, and Jackson was convicted.

In theory, any ridged body part can be used as a means of identification, although the police do not keep files of every body part. Toe prints, footprints, palm prints, and even lip prints have all provided investigators with evidence.

In the past, some criminals went to wild extremes to prevent leaving fingerprint evidence. American gangster John Dillinger had his fingertips treated with acid to remove the ridge patterns (they grew back). Criminal Robert Phillips had the skin on his fingertips removed by plastic surgery, and replaced with skin grafts taken from his chest. Phillips was caught based on ridge evidence from the undoctored lower parts of his fingers.

Most of us are familiar with the use of dental records in identifying a body. Teeth decay far more slowly than bones, and can withstand burning in a fire. People who visited the dentist frequently and have had many dental treatments are easiest to identify. If the subject has no teeth, studying dentures and x-raying the mouth and skull can provide some evidence.

Every time a gun is fired, it leaves behind identical marks on the bullets and cartridge casings. No two guns leave the same marks; they are as unique as human fingerprints. These ballistic fingerprints help law enforcement agencies solve gun crimes by identifying the specific weapon used in a crime.

Looking at the way blood drops and splashes helps police determine the positions of the victim and criminal at the time of an assault.

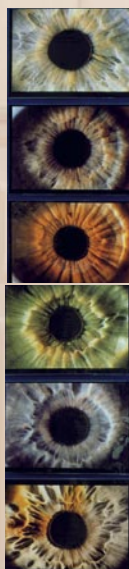

QUESTIONS AND ANSWERS

Q What is identity theft? Where can I get advice on preventing it?

A Identity theft may be the fastest-growing crime in the world. It is defined as the adoption of a person's identity for financial gain, or to aid in committing a crime. Identity thieves often open new credit card accounts and run up huge bills, or access bank accounts and empty them of funds. The Federal Trade Commission Web site (www.ftc.gov) has tips to help you protect your identity.

Q How does retinal scanning work?

A Retinal scanning analyzes the layer of blood vessels at the back of the eye. The scanning device uses a low-intensity light and an optical coupler to read the patterns. The user looks through a small opening in the scanner and focuses on a small green light for several seconds; the pattern is matched with one already on file to verify identity. As early as the 1930s, scientists discovered that these patterns were unique to each individual, but it took some time for technology to catch up. The first scan device for commercial use was introduced in 1984.

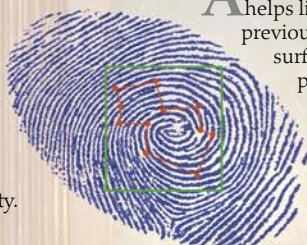
Q What is luminol, and how do crime scene investigators use it?

A Sometimes at a crime scene, the blood has been washed away. How do investigators find out where it was? They spray the area with a chemical called luminol. This chemical reacts to hemoglobin (the oxygen-carrying protein in red blood cells), glowing greenish blue when it comes into contact with traces of blood. Investigators usually dim the lights so the glow is easy to see, then spray the chemical over a wide area and photograph or videotape the result.

Q What is computer forensics, and why is it important?

A The analysis of home computers and computer servers to determine if the computer has been used for illegal (or suspicious) activities is called computer forensics. It is becoming an important key in cracking criminal cases, since anything that helps police build up a picture of a suspect's interests and circle of contacts before the crime was committed is very useful.

Q How can investigators make sure they find as many fingerprints as they can at a crime scene?



Fingerprint

A One everyday substance helps lift fingerprints from previously stubborn surfaces such as mirrors, plastic bags, or car windows: super glue. A chemical in the glue called cyanoacrylate is attracted to the fats and proteins left behind by a human

touch. The item to be checked for fingerprints is put in a sealed tank. The glue is heated in a metal cup inside the tank. The glue vapor attaches itself to any fats and proteins, leaving behind a record of the fingerprint.

Q Are lie detector tests accurate?

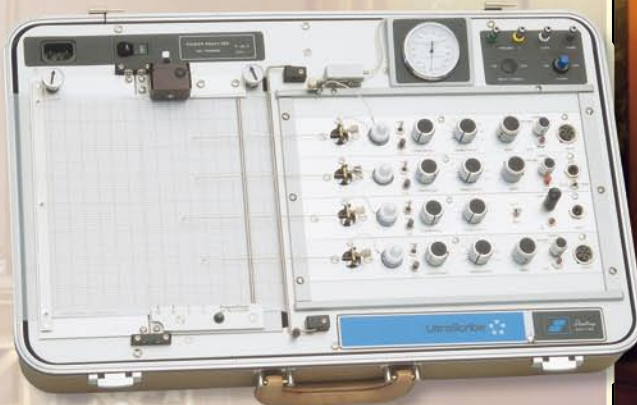
A The polygraph, or lie detector, is a machine that measures changes in the breathing rate, blood pressure, and perspiration of a crime suspect. The suspect is hooked up to the machine and asked to answer questions, including those with known answers such as age and sex. The person administering the test looks for changes in body responses when the subject tells the truth—and when he or she does not! The test results are not accepted as evidence in court unless a judge allows it. Scientists are working on more accurate methods, such as voice analyzers that look for the tremors in speech that appear when a person lies.

Q What is mass spectrometry, and how is it changing the field of forensics?

A A machine called a mass spectrometer identifies forensic samples, such as blood or explosives, by examining their molecular mass. Tiny droplets of water are sprayed at the sample, dislodging some of its molecules, which are sucked into the spectrometer for analysis. In 2004, scientists at Purdue University created a portable spectrometer. This machine could be taken to a crime scene and used on the spot, with no need to send evidence off to a lab for analysis.

Q What is psychological profiling? How is it used?

A In the 1950s, psychologists began to study common behavior patterns and personality traits in criminals. Police worked with these experts to determine the type of person who may have committed a particular crime. In the 1970s, the FBI established a Behavioral Science Unit where profilers examined crime cases, looking for details that might provide clues about a criminal's background and motivation. A profile includes general information such as the age or sex of the criminal, as well as specific details.

LONGEST CRIMINAL TRIAL IN THE U.S.

The McMartin trial, which tried seven owners and teachers of a California preschool on charges of abuse, was the longest (1984–1990) and costliest (\$13.2 million dollars) trial so far on record.

BIGGEST HEIST IN HISTORY

Gold, currency, and jewels worth an estimated \$2.5 billion dollars were snatched in the German Riechsbank robbery in 1945.

LARGEST ART THEFT IN US HISTORY

In 1990, a dozen paintings, collectively worth \$100 million dollars, were stolen from the Isabella Stewart Gardner Museum in Boston, MA.

LARGEST JEWEL HEIST

A 2003 raid on high-security vaults at the Diamond Center in Antwerp, Belgium, netted more than \$100 million in jewels, gold, and securities.

c. 1750 BCE

King Hammurabi of Babylon issues a legal code, the first written code of laws yet discovered. The code contains 281 laws, including the well-known rules, "an eye for an eye" and "a tooth for a tooth."

c. 1200 BCE

According to the Old Testament, the prophet Moses receives the Ten Commandments from God. These divine laws have an important place in the ethical systems of Judaism, Christianity, and Islam.

621 BCE

The Greek ruler Draco creates notoriously harsh codes of law; most crimes are punishable by death.

c. CE 200

The Mishnah, the first recording of Judaism's oral laws, is compiled.

534

Roman Emperor Justinian collects all existing Roman laws into a simple and clear system of laws. His work is known as the Justinian Code.

c. 570

The prophet Muhammad, founder of Islam, is born in Saudi Arabia. Muslims believe that God revealed laws to him that form the basis of Islamic faith and law.

1110

The White Tower is completed at the Tower of London, England. The Tower serves as a prison and place of execution; famous prisoners over the years includes Sir Walter Raleigh, Ann Boleyn, and Guy Fawkes.

1382

Construction ends on the Bastille, built to defend the eastern part of Paris, France; this stronghold later becomes a prison.

1605

English soldier Guy Fawkes is caught making a huge bomb underneath the Houses of Parliament in London, England. He was executed for conspiring to kill the king and members of Parliament.

1667

The first French police force is founded by Marquis de Louvois and Gabriel La Reynie.

1671

Disguised as a parson, the Irish rogue Thomas Blood attempts to steal England's Crown Jewels. He is arrested with a crown, orb, and scepter.

1716–1718

British pirate Blackbeard (whose real name was thought to be Edward Teach) and his crew terrorize sailors on the Atlantic Ocean and the Caribbean Sea.

1787

Great Britain begins transporting prisoners to Australia.

1789

A crowd in Paris, France, storms the Bastille, releasing the prisoners, marking the beginning of the French Revolution.

1829

The Metropolitan Police Act, proposed by Sir Robert Peel, establishes police force in London at Scotland Yard. Officers are nicknamed "bobbies" after Peel.

1848

U.S. lawman and gambler Wyatt Earp is born.

1852

The Pinkerton Detective Agency is founded in Chicago. Its logo was an open eye with the words, "We never sleep." This is the origin of the term, private eye.

1873

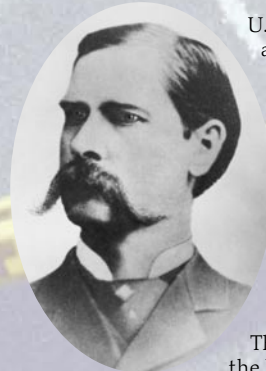
The Canadian government forms the North-West Mounted Police (popularly known as "Mounties").

1873

The notorious James brothers, Jesse (1847–1882) and Frank (1843–1915), lead a gang of bandits in their first train robbery.

1881

American outlaw Billy the Kid (c. 1859–1881) is hunted down and shot by Sheriff Pat Garrett.

1888

Jack the Ripper terrorizes London, England. He kills seven women but eludes capture.

1892

Sir Francis Galton publishes his book on fingerprinting, significantly advancing the science of fingerprint identification.

1893

A U.S. court finds Lizzie Borden (1860–1927) not guilty of killing her parents with an axe. Her trial inspires a popular schoolyard chant.

1896

Wild West outlaw Butch Cassidy (1866–c. 1909) forms the Wild Bunch, a league of train robbers.

1908

The Siberian mystic Rasputin (1869–1916) heals the sick son of the Russian czar and gains power over the Imperial Family; he is murdered in 1916 by other royals.

1908

The Federal Bureau of Investigation (FBI) is created in the United States.

1909 MI5

Originally called the Special Intelligence Bureau, the British intelligence bureau called the MI5 is founded.

1910

American murderer Dr. Hawley Crippen (1862–1910) is captured while on the lam, after a ship's captain spots the disguised doctor among his passengers and sends a message to the press and police via the newly invented radio.

c. 1910

Frenchman Edmund Locard proposes a concept known as "Locard's Exchange Principle" which states that whenever a criminal comes into contact with a victim, object, or a crime scene, he or she will leave behind (and take away) evidence.

1911

British archeologist Charles Dawson reveals the first of many fossil finds (including the remains of the so-called Piltdown Man) that are shown to be hoaxes in the 1950s.

1919

American swindler Charles Ponzi defrauds thousands of people with his promise to double the value of their original investments in just 90 days. Today, these financial scams are called Ponzi schemes.

1919

In baseball's World Series, eight players from the Chicago White Sox are accused of "fixing" the Series to give the championship to the Cincinnati Reds. The scandalous team is dubbed the "Black Sox" in the press.

1929

Throughout the 1920s, Chicago gangland legend Al Capone led a crime spree culminating in the St. Valentine's Day Massacre on February 14th, in which seven men are killed with 150 bullets.

1932

The child of American aviation legend Charles Lindbergh is kidnapped in a case that enraptured the nation; although the ransom is paid, the baby is killed. Two years later, FBI agents track down the murderer by tracing the ransom money.

1934

Police officers ambush and kill Bonnie Parker (b. 1910) and Clyde Barrow (b. 1909), an infamous pair of U.S. bank robbers.

1934

The Federal Penitentiary at Alcatraz Island in the San Francisco Bay ("The Rock") opens its doors.

1947

The National Security Act establishes the Central Intelligence Agency (CIA) in the United States.

1950

The Israeli intelligence agency MOSSAD is founded.

1953

The infamous Russian Committee of State Security (KGB) is founded.

1958

The Service de Documentation Extérieure et Contre-Espionage (SDECE) is created in France; in 1982, it is replaced with the DGSE.

1960s

The first computer hackers emerge, predominantly at MIT in Boston, MA. The word "hack" was used at MIT to describe a particularly inspired prank.

1963

In the Great Train Robbery, Britain's most famous theft, a gang of thieves steals used banknotes from mailbags carried on a train.

1974

Patty Hearst, granddaughter of a legendary newspaper publisher, is kidnapped; two months later, she appears in a bank robbery video brandishing a gun. Hearst is later arrested and sent to prison for her crime, despite her lawyers claim that she was brainwashed at the time.

1984

DNA evidence becomes the universal standard for identification, ultimately changing the face of detective work.

1992

John Gotti, the head of a major crime family in New York City, is charged with racketeering and sentenced to life in prison without parole.

1994

Phoolan Devi, better known as India's "Bandit Queen" is released from prison, becoming a folk hero.

1995

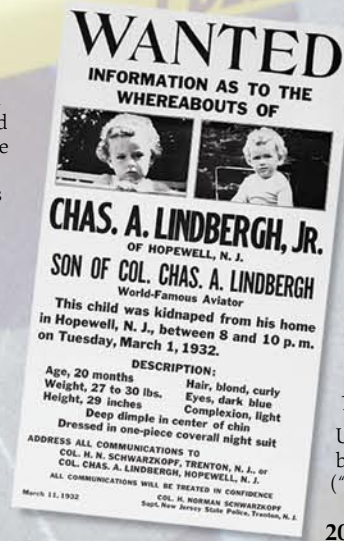
In a trial that created a media sensation around the world, former American professional football player O.J. Simpson is found not guilty of murder.

1998

U.S. math professor-turned-mail-bomber Theodore Kaczynski ("The Unabomber") pleads guilty.

2004

In a high profile case that gripped the media, Californian Scott Peterson is found guilty of killing his wife and unborn child. In 2005, Peterson is sentenced to die for his crime.

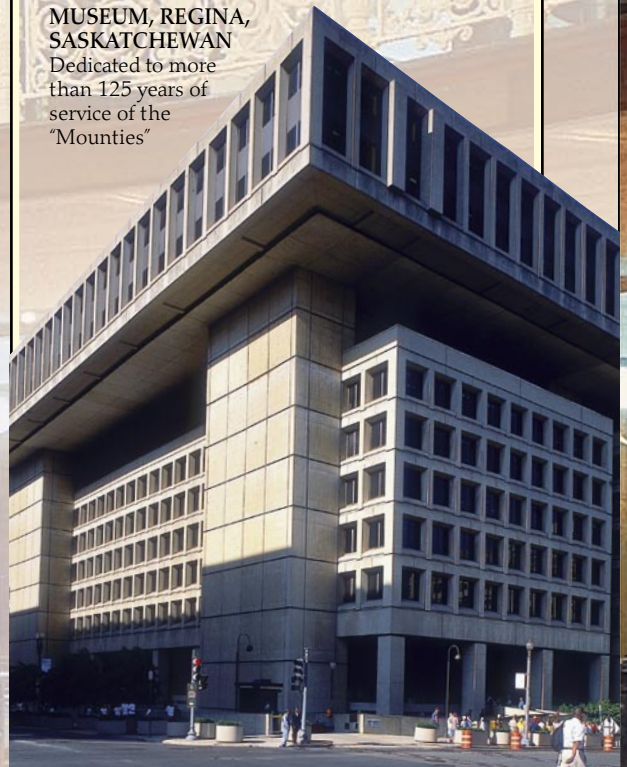

Glossary

AMPEL PROBE A tool used to inspect evidence without the risk of contamination or exposure. An ampel probe works like an extension of the human hand.

ANTHROPOMETRY An identification system based on the measurement of body parts. Developed in 1892, it was the first scientific system used to identify criminals.

ARSON The crime of voluntarily setting a building on fire for an unjust reason; for example, burning one's own home in order to collect insurance money

ASSASSIN Someone who sets out to kill another individual. Assassins especially target prominent public figures.

AUTOPSY The examination of a cadaver, or dead body in an attempt to identify its cause of death.

BAIL Money given to a court as security when a person accused of a crime is released from jail. Bail is forfeited if the accused fails to appear.

BALLISTICS The study of how weapons function

Armor that entirely protects the person wearing it. Someone is likely to wear body armor when entering a dangerous situation.

BOOTLEG To produce, distribute, and sell something without receiving permission; also, an item sold in this way. People often create bootleg copies of videos or CDs.

BOUNTY HUNTER

A person that searches for a criminal or fugitive for the purpose of obtaining the reward money.

BURGLARY The act of entering a building with the intention of stealing or committing a crime.

CENTRIFUGE A machine or device that spins a container very quickly, leading to the separation of liquids and solids through centrifugal action; often used in forensics

COMMON LAW A legal system based on decisions made in a courtroom rather than decisions made by the legislative branch of government

CONVICT A person who has been found guilty of committing a crime

COUNTERFEIT A false copy or replica of something genuine

CRIME SCENE The location where a crime was committed. Crime scenes are usually closed off so that police may search the area for evidence.

CRIME WAVE A sudden increase in the number of recorded crimes

DEFENSE Something that gives protection against danger

DENTAL IDENTIFICATION The practice of inspecting people's teeth after their death in order to help identify them. This system is precise because no two people have identical dental histories.

DETECTIVE Someone who investigates crimes, either as part of a government agency or on a freelance basis



Centrifuge

DNA EVIDENCE Evidence based on DNA, the unique genetic coding found in our cells. Usually, DNA found at a crime scene (in blood or tissue, for example) is compared with DNA taken from a suspect in order to prove their involvement.

EVIDENCE Something that points towards a specific idea or conclusion

EXPLOSIVES A chemical substance that has the ability to create an explosion. Explosives are often used as weapons or a means to cause harm.

EXTORTION The practice of illegally obtaining something, usually money, through force or intimidation

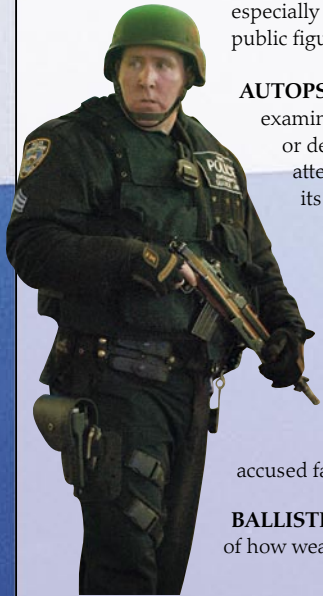
FINGERPRINT ANALYSIS The investigation or breakdown of the unique set of ridges on the tip of a finger, also known as a fingerprint

FIX To establish something as definite. Also, to influence the result of an event (a horse race or an election, for example) to one's advantage by bribery, trickery, etc.

FORENSIC SCIENCE

A branch of science dedicated to solving crimes by examining the evidence, using advanced technical procedures. A forensic examination can often explain how someone died.

FORGERY The act of creating an illegal duplicate of something in a deceptive manner. Common examples are forged signatures or documents.

GANGSTER A member of a professional crime organization

HIGHWAYMAN A term used in the past to signify an armed man on a horse who stole from people traveling on public roads

HOSTAGE Someone who is taken prisoner by an armed individual in order to persuade others to adhere to the hostage-taker's commands and orders

JUSTICE The maintaining of fairness and propriety, especially through laws

KIDNAPPING To forcefully take a person into possession, usually with the intention of requesting money in exchange for the person's release

LARCENY The act of stealing from another person without actually trespassing or invading anyone's property

LAW Rules and regulations enacted by society to maintain and establish order

LOOT To steal from stores and shops while violent or distracting events, such as a power outage or a riot, are occurring

MAFIA A criminal organization that originated in Sicily and continues to be active in Italy and the U.S. This close-knit group is notorious for going to violent extremes to protect its members.

MONEY LAUNDERING Anything done with the intent of hiding the source of illegally obtained money

NIGHT STICK A police baton used for hitting or restraining a criminal

ORGANIZED CRIME Crimes that are committed by members of criminal organizations or groups

PARDON An official act releasing someone from all penalties for a particular crime

PETTY THEFT The act of taking something insignificant or worthless that does not belong to you

PICKPOCKET A thief who robs or steals from purses, pockets, or wallets, often in a large crowd

PIRACY The illegal distribution of unauthorized intellectual property. This most often describes the theft of computer software, music, or movies.

POLICE LINEUP The process of arranging suspects in an organized row so that a victim may attempt to visually identify the guilty party

PROHIBITION The act of making something officially forbidden or illegal

PROSECUTE To bring someone to court and officially accuse them of being guilty of a particular crime

RANSOM An amount of money that is demanded by a criminal, particularly a kidnapper, in exchange for the release of someone who has been taken prisoner

RANSOM NOTE A note left by a criminal or kidnapper that lists what they are demanding in exchange for the release of a prisoner

REFRACTIVE INDEX A property of a material that determines how much light will bend when it passes into that material from another. The greater the difference in the refractive index of two materials, the more the light will bend.

SENTENCE To impose a specific punishment on someone who has been found guilty of a crime

SMUGGLE To secretly bring people or items to or from a place, in violation of the law

STATUTORY LAW A law that has been officially approved and recorded

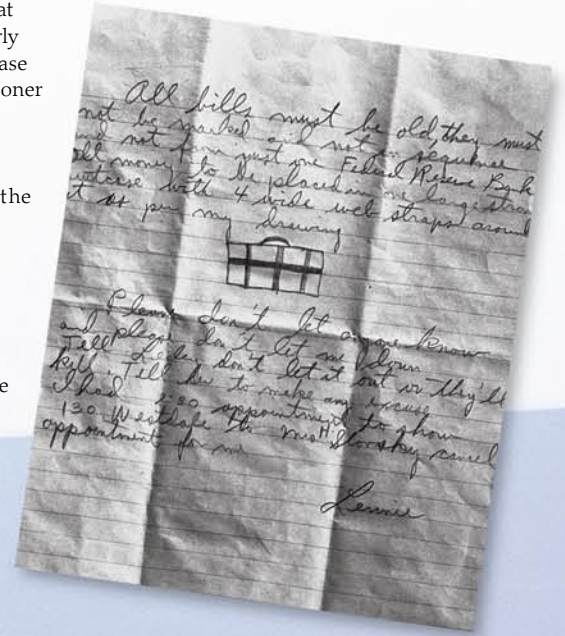
STAKEOUT The ongoing surveillance of a particular place thought to be a center of criminal activity

STOCKS In the Middle Ages, a wooden frame enclosing one's hands, feet and, neck as a form of humiliating public punishment

SURVEILLANCE The act of keeping a close eye on a person or location, often as part of a criminal investigation

SWINDLE To obtain something through deceitful and criminal action

TAX EVASION Any instance where someone attempts to illegally avoid paying taxes, usually through dishonest reporting

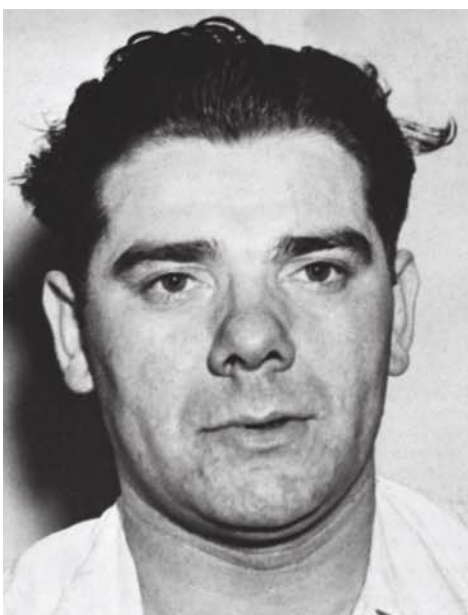
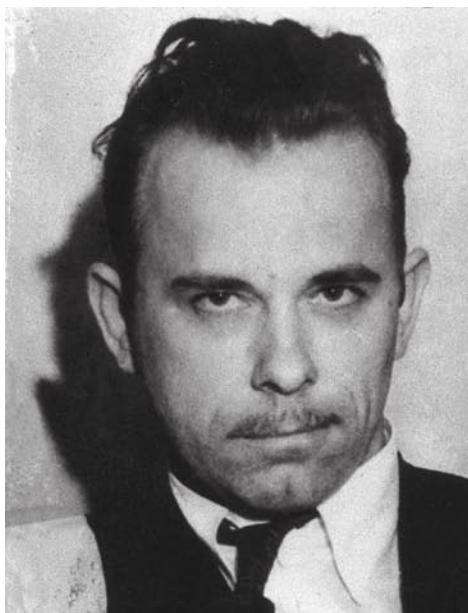
TELEPHONE TAP A common police and government method of listening in on a suspected criminal's phone conversation as part of an investigation

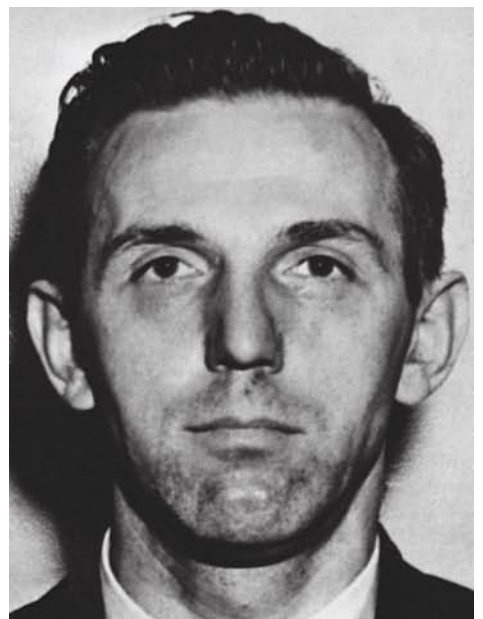
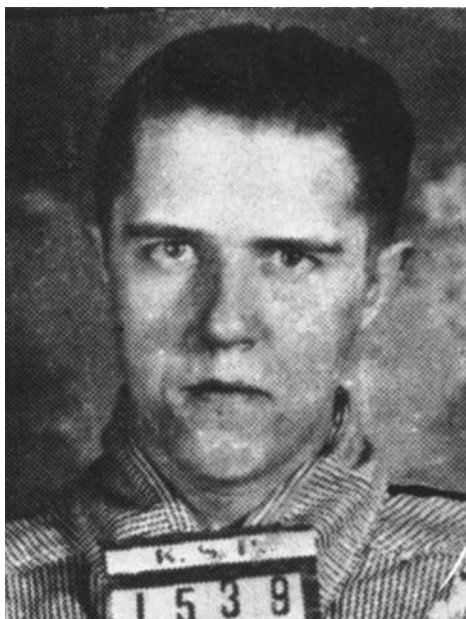
TERRORISM An act of violence or cruelty intended to intimidate a government into meeting certain political demands

ULTRAVIOLET LIGHT Light which has a wavelength that is beyond the color violet in the range of colors that are visible to human beings. Ultraviolet light, or UV, causes skin to grow darker in the sun.
